Subject of Report	Motor Neurone Disease Charter Adoption
Executive Summary	Motor Neurone Disease (MND) describes a group of diseases that affect the nerves in the brain and spinal cord which communicate with muscles. When a person has MND, messages from these nerves gradually stop reaching the muscles, causing them to weaken, stiffen and waste. The disease is rapidly progressive and always fatal.
	On 19 July 2018 the County Council received a public statement from Dr. Richard Sloan, the Chair of the West Dorset Branch of the Motor Neurone Disease Association. The statement explained that the disease kills 30% of people within 12 months of diagnosis and 50% within two years. The County Council was asked to adopt the MND Charter as a statement of intent to provide prompt support to sufferers and their families. The request was made in the hope that adoption of the Charter would lead to a partnership which will help to ensure that the right support is provided to people, when and where it is needed.
	Councils can play a key part in delivering a number of the points in the Charter - so the Association's 'Champion the Charter' campaign is designed to ensure councils are better informed about the needs of people with MND. Around 76 councils In England, Wales and Northern Ireland have adopted the Charter to date.
