- (a) Peter Farrell on 1 April 2013, who served on the County Council between May 2001 and May 2009, representing the Weymouth Town Electoral Division.
- (b) William Wells on 29 April 2013, who served on the County Council from 1977 to 1989, representing the Wimborne and Cranborne Electoral Division from 1977 to 1985 and the Verwood Electoral Division from 1985 to 1989.

30.2 Members paid tribute to the dedication and commitment of both former members to Dorset and within their divisions and the County Coujcil stood in silent tribute.

Election Return

Business Brought Forward by the Chairman

- 33. The Chairman reported the following events since the last meeting:-
- (i) Youth Parliament Elections (14/02/13)

The Chairman reported that Lloyd Hatton, Moya Dunne and James Jones had been elected Members of the Youth Parliament, and James Morphakis, Natasha Glendening and Eve Laird had been elected as Deputy Members.

(ii) High Sheriff Declaration Ceremony

The Chairman had attended the swearing in of Mrs Catriona Payne JP as the new High Sheriff and replacing Mr Jeremy Pope the previous High Sheriff.

- (iii) Hall and Woodhouse Community Chest
 - The Chairman had attended the launch of Hall and Woodhouse's 2013 Community Chest which supported a number of local causes.
- (iv) Dorset School Games (22/3/13)

School games were held twice a year and the Chairman had attended the Games held in March at Canford School, Wimborne.

(v) Movie Mash-Up at the Royal Albert Hall

The Chairman reported on the concert held at the Royal Albert Hall on 3 May 2013. This involved renditions of many film scores and involved 1500 young musicians from across Dorset.

(vi) New People

The Chairman welcomed Catherine Driscoll, Director for Adult and Community Services and Dr David Phillips, Director of Public Health, to their first meetings of the Council. He welcomed Paul Kent to his first meeting as Director for Corporate Resources and thanked Harry Capron for his work as Acting Director for Adult and Community Services whilst the recruitment process for the new Director was undertaken. He also welcomed new members of the County Council and paid tribute to the previous Leader of the Council, Angus Campbell.

Public Question Time

34. There were no questions from members of the public.

Leader of the Council and the Cabinet

- 35.1 Member were invited to appoint the Leader of the Council for a four year period from 2013 to 1017. On being put to the vote Spencer Flower was duly elected as Leader of the Council.
- 35.2 The County Council Member for Dorchester (Trevor Jones) welcomed Spencer Flower as the new Leader of the Council and paid tribute to the work of the previous Leader, Angus Campbell. As Chairman of the Audit and Scrutiny Committee, he hoped to provide a constructive and appropriate challenge to Mr Flower and members of the Cabinet.

Resolved

- 36.1 That Spencer Flower be appointed Leader of the Council for the period up until the annual meeting of the County Council in 2017, or until the Cabinet resolved to the contrary.
- 36.2 That the following appointments made by the Leader be noted:-

(Note - The Leader and Deputy Leader of the Council are, ex-officio, Chairman and Vice-Chairman respectively of the Cabinet.)

Delegated Executive Functions

- 37.1 The Council considered a report by the Monitoring Officer on the existing scheme of delegation of executive functions to officers.
- 37.2 The Leader stated that there had been no changes to the current scheme of delegation but that a substantial review would be carried out by the Monitoring Officer. This outcome would be reported to a future meeting of the Council.
- 37.3 The County Council Member for Colehill and Stapehill referred to powers delegated to the Director for Environment, after consultation with the appropriate Cabinet Member, in relation to the withdrawal of subsidy from low priority bus services if District Councils were unable to provided the necessary additional financial support to continue to run such services. She drew attention to the implications such a decision could have on members of the public and that this could be done without any reference to local members. The Leader confirmed that no single member made such decisions, that a period of consultation would have been undertaken prior to a report being provided for the Cabinet to consider which would provide local members an opportunity to attend.

- 37.4 The County Council Member for Portland Tophill drew attention to the lack of public transport to the Grove area of Portland. The Leader explained that all aspects of transport were to be reviewed.
- 37.5 The County Council Member for Bridport was concerned about the withdrawal of low priority bus services and suggested the removal of this delegation from the scheme. She expressed the need for such decisions to be fair, evidence based and transparent to members and the public. The Chairman clarified that before a delegation was exercised, the local member should be consulted and the matter referred to the Cabinet if appropriate.
- 37.6 The County Council Member for Blandford highlighted the importance of the local member role and the need for them to be consulted about activities in their own areas.

Resolved

38. That the statement of the former Leader of the Council be noted.

Reports of the Cabinet

- 39.1 The reports of the Cabinet meetings held on 6 March and 3 April 2013 were presented and their adoption duly moved and seconded.
- 39.2 The following matters were raised under the minutes of the meeting held on 6 March 2013:-

<u>Corporate Performance Monitoring Report, third Quarter 2012-13 and Draft 2013-14 Refresh</u> of the Budget and Corporate Plan

- 39.3 On minute 147.5 the County Council Member for Corfe Mullen drew attention to the number of complaints she had received from members of the public about the poor state of roads and sought reassurance that there would be a programme for the repair of potholes. The Cabinet Member for Public Health and Communities, as the former Cabinet Member for Highways and Transportation, confirmed that there was an extensive programme to repair potholes. The number of potholes had tripled due to adverse weather conditions and the Government had provided an additional sum of £3M in recognition of the current situation.
- 39.4 The County Council Member for Lytchett referred to the different categories of pothole and asked that when workmen were sent to repair them, that they dealt with all potholes in the area rather than having to return at a later date to carry out further repairs. The Cabinet Member for Public Health and Communities referred to recent member briefings which had provided information about pothole classification and timescales for repair. This information was available on the Dorsetforyou website.

Reprovision of Children's Residential Accommodation

- 39.5 On minute 168.2 the County Council Member for Weymouth Town asked for more information about the Children's Services overspend of £2.2M. The Cabinet Member for Education and Communications explained that this related to increased numbers of children entering care and the related increase in costs. The situation was under constant review.
- 39.6 The following matters were raised under the minutes of the meeting held on 3 April 2013:-
- 39.7 It was confirmed that no additional amendments to the Budget and Corporate Plan had been made by the Chief Executive, after consultation with the previous Leader.

Budget and Corporate Plan: Draft Refresh 2013-14

- 39.8 The County Council Member for Weymouth Town drew attention to page 21 of the minutes and the challenge headed "Economy". He indicated that this presented the bare facts of a negative base, did not include how economic development and growth could be achieved, what support was provided, and how innovation was encouraged. The Leader accepted this and referred to the forthcoming peer review which would address the growth agenda and influence future actions by the County Council.
- 39.9 The County Council Member for Portland Tophill referred to the need for more apprenticeships to be given to young people in order to provide them with a future. The Cabinet Member for Education and Communications added that the Raising Participation Board wanted to increase the number of young people going into jobs with training in order to improve their futures.
- 39.10 The County Council Member for Westham referred to the Headline Facts set out on page 24 of the minutes and the fact that people living in urban areas could also experience a poor public transport network. He suggested that the second bullet point on page 35, Aim 1 should be amended to read "... sports, opportunities for physical activities and adult ..." and he sought the Cabinet's agreement to these changes. The Leader reminded members that this was the last year for the current Corporate Plan and a review of it would be undertaken over the next few months. These comments would be considered during this review.
- 39.11 The County Council Member for Dorchester (Trevor Jones) reminded members of the previous need for a reduction in the number of people killed or seriously injured in Dorset which had led to the introduction of the "No Excuse" campaign. Performance in this area had improved but local authority funding cuts had impacted on the campaign. The Audit Committee had raised the issue of why the NHS did not contribute funding to it when, as a result of the campaign, there were fewer attendances at A and E Departments and fewer calls on the Ambulance Service. He suggested further approaches to the NHS for funding of the campaign. The Leader agreed that a request could be made but was unsure that it would be successful. The Cabinet Member for Public Health and Communities added that the Dorset Road Safe Partnership continued to seek funding from the NHS. He agreed with the sentiments expressed, highlighted the success of the No Excuse campaign and the need for funding current to be reviewed. The County Council Member for Dorchester requested that an item on the campaign be placed on the agenda for the next meeting of the Audit and Scrutiny Committee and that the Director of Public Health and the Cabinet Member for Public Health and Communities attend.
- 39.12 The County Council Member for Westham drew attention to the transfer of Public Health to the responsibility of the local authority from 1 April 2013 and highlighted the need for an integrated approach as health impacted on all parts of the County Council's work. The Cabinet Member for Public Health and Communities confirmed that an integrated approach was to be adopted.
- 39.13 The County Council Member for Burton Grange referred to the climate change concept and suggested that spending on this be reviewed as questions were being asked about its validity.

Growing Places Fund

39.14 On minute 221 the County Council Member for Weymouth Town asked how much of the £9.6M Growing Places Fund had been spent in Dorset and sought assurance that every effort was being made to ensure that Dorset received its share. The Leader agreed to provide this information following the meeting.

Queen Elizabeth's School, Wimborne, Position Statement

39.15 On minute 249 the County Council Member for Dorchester (Richard Biggs) asked for information about the original tender estimate of the building project, the final not to be exceeded figure and requested that if this was exceeded the matter be considered by the County Council rather than the Cabinet. The Leader asked that officers send a statement to all members following the meeting.

(Note: It was subsequently clarified that the position in relation to Audit and Scrutiny Committee members sitting on Overview Committees had been relaxed in 2005 to allow this to take place.)

The Director for Corporate Resources stated that looking forward to 2020 there were no indications that a negative cash flow would be reached. The possibility of a financial downturn due to members opting out of the scheme had not materialised and the new scheme would commence in 2014 with the potential for members to elect to receive a smaller pension for half the contributions. The Fund currently had a surplus annual turnover of £30-£35M.

53.2 The following matter was raised under the minutes of the meeting of the Dorset Shadow Health and Well-being Board held on 27 February 2012:-

Outcome of the Development Work with the Local Government Association (LGA) – Establishing a Statutory Board

- 53.4 On minute 8, the Vice-Chairman of the Council explained that the meeting on 27 February 2013 had been the Shadow Board's final meeting prior to the statutory Board coming into effect on 1 April 2013. The LGA had provided options for the structure of the Board. Representation of GPs and elected members on the Board was a key issue and it had been agreed that the current membership should continue and be reviewed in six months time with a view to reducing the current membership. A statement of purpose provided by the LGA had been included in the terms of reference.
- 53.5 The County Council Member for Bridport moved an amendment to recommendation 9 that the working of the Dorset Health and Well-being Board be reviewed after six months. She referred to concern at District Council level about the reduction in the size of the Board which would see the removal of district members. It was important for local input into discussions about strategy and she referred to the Clinical Commissioning Group's arrangements which allowed for this by way of locality teams. The Cabinet Member for Education and Communications who had previously sat upon the Board stated that the current size of the Board made it unwieldy. She referred to the Children's Trust Board which had had a similar problem with size when it was first established but this had reduced over time. Now discussions at a local level were reported to the main Board and a similar arrangement could work for the Health and Well-being Board. She reminded the Council that the Board had agreed to this recommendation.
- 53.6 The County Council Member for Westham, who had seconded the amendment, spoke in support of the reviewing the work of the Board in six months time before making further recommendations on its membership. The amendment was lost on being put to the vote.

Questions Under Standing Order 20

Question from Paul Kimber to the Leader of the Council

Question

Recognising the importance of SAR (Search and Helicopter Rescue) based on Portland serving the community of Dorset. The public in Dorset have clearly expressed their support for the retention of this vital service. The planned replacement service does not replace the former service located in Dorset.

Please can you confirm if the Council would call for an urgent meeting with the Government Minister to retain this vital service?

<u>Answer</u>

The County Council has not been consulted about the removal of the Portland Helicopter. Indeed there has been no consultation with those affected by the withdrawal.

There has been considerable concern raised about the lack of consultation on these changes on a national basis and the Parliamentary Select Committee on Transport has expressed surprise at the lack of consultation and has made its views known that it believes consultation should have taken place.

There is a petition being sponsored by Mr Richard Drax MP asking for the decision to be reconsidered and for the Portland helicopter to be retained. Anyone can add their name to the petition on the e-petitions part of the direct.gov web site, the petition closes in July would need to reach a 100,000 signature threshold in order to prompt a backbench business committee debate.

However, in response to the petition so far the Government are saying that they have already awarded the contract for SAR to Bristow and that the new arrangements provide better and faster coverage, albeit not based at Portland.

The County Council has no formal role to play in this process but I am able to confirm that I will write to the Secretary of State for Transport make clear the concerns expressed by many local residents and business.
