Subject of Report	Update on Transforming Mental Health Services for Older People in the East of the County
Executive Summary	<p>In March 2012 the Joint Health Scrutiny Committee received a paper on the Transformation of Mental Health Services for Older People in the East of Dorset (Appendix 1).</p> <p>As the Joint Health Scrutiny Committee on NHS Transformation is no longer constituted NHS Dorset Clinical Commissioning Group, as service commissioners, and Dorset HealthCare Trust, as service providers, have been asked to provide a joint report to update this Committee about this work. The 2012 report to the Joint Committee suggested service changes in the east would be completed by March 2013 and similar service changes for the west of Dorset were expected to take place during 2013/14.</p> <p>An update report has been provided as requested (Appendix 2).</p>
