### **UK Equity Report**

### Report of the Internal Manager

- 1. Purpose of the Report
- 1.1 To review the management of the UK equity portfolio.
- 2. Recommendations
- 2.1 That the report and performance be noted.
- 3. Background
- 3.1 The UK Equity portfolio has 3 active managers, AXA Framlington, Standard Life and Schroders as well as the internally managed passive fund. This combination of managers and styles is designed to give the opportunity of outperformance against the FTSE All Share index and has a two thirds passive and one third active mix. Details of the combined portfolio (£580.6M at 31 March 2014) are shown in the table at paragraph 5.2.
- 3.2 The internally managed passive fund aims to track as closely as possible the FTSE 350 index which measures the progress of the majority of the UK equity market. At 31 March 2014, the FTSE All Share index was made up of 623 individual stocks ranging from HSBC Holdings, the largest UK company (market value £119.7 Billion) down to the smallest in the index, RusPetro Plc (market value £23.3 Million). Direct investment is made in the largest 350 companies, which comprises 97.2% by value of the index. Investment in the smallest companies which make up 2.8% of the index is achieved by a holding in the Schroders Institutional UK Smaller Companies Fund which is managed on an active basis.

#### 4. Market Background

- 4.1 Although UK equities finished the quarter to 31 March 2014 flat in performance terms, the period showed significant swings in sentiment that related to overseas developments. In particular, tapering-related capital outflows from emerging markets and associated currency weakness saw the quarter start weakly. In addition, escalating tensions in Ukraine towards the end of the quarter caused further investor anxiety. This ensured the period ended as it began, with renewed stock market weakness.
- 4.2 All UK Equity markets rose in the six month period to March 2014 with the FTSE250 Index performing the best, rising 9.2% (1,366 points), whilst the FTSE100 was the worst performing major UK index rising 2.1% (136 points). In comparison, all major world indices rose in the same period with the exception of the Hang Seng which fell 3.1% (709 points). The Dow Jones rose 8.8% (1,328 points) over the same period.
- 4.3 All UK markets rose during the twelve month period to March 2014 with the Small Cap performing best, rising 17.5% (668 points), whilst the FTSE100 was the worst performing major UK index rising 2.9% (187 points). The FTSE100 hit its highest closing point during the year on 24 February 2014 at 6,865.9, which was its highest level since 1999. In comparison, all major indices rose over the same period apart from the Hang Seng which fell 0.7% (149 points), whilst the best performing major

world index was the Dax, rising 22.6% (1,761 points). The Dow Jones rose 12.9% (1,879 points) over the same period.

- In January, the Office for National Statistics confirmed the UK economy grew by 0.7% in the fourth quarter of 2013, bringing the annual growth rate to 1.9%. This was the fastest annual rate of growth since 2007. Growth in this quarter was down slightly on the previous quarter's 0.8% figure although the annual growth remains well below the 3.4% of 2007. The UK's service sector, which makes up more than three quarters of economic output rose by 0.8%, matching its performance from the previous quarter. Industrial production fell slightly from 0.8% to 0.7% due to falling North Sea oil and gas output. The construction sector, which accounts for less than 8% of GDP fell 0.3% in the quarter, despite the recent recovery in the housing market aided by the government's Help to Buy scheme.
- In January, it was announced that the UK's inflation rate had fallen to 2% in December, down from 2.1% the previous month. It was the first time inflation had been at or below the government-set target of 2% since November 2009. The fall was caused by slower increases in the prices of food and non-alcoholic drinks, the smallest rise since 2006. Discounts up to Christmas also helped to lower the inflation rate, with the prices of toys and computer games falling at a faster rate last month than a year ago. However, rises in gas and electricity bills as well as rising petrol prices had an upward effect on inflation.
- 4.6 In January, the US Commerce Department announced the US economy grew at a much slower rate than originally predicted. US GDP grew at an annualised rate of

- 2.4% in the fourth quarter of 2013, down from an initial estimate of 3.2% and lower than the 4.1% growth in the previous quarter. The revision was due to weaker than expected consumer spending, which accounts for approximately 70% of US economic activity. This was initially predicted at 3.3% but has since been changed to have grown at an annual rate of 2.6%, which was the highest quarterly reading of 2013. The US growth was affected by the sixteen day shutdown of the government in October and the severe winter weather which led to a decrease in vehicle sales. For 2013, the economy grew at a rate of 1.9%, although the contraction in public spending and higher taxes knocked about 1.5% from growth. These measures were put in place to try to counter soaring budget deficits. In comparison, the US economy grew 2.8% in 2012.
- In February, Eurostat, the EU's statistics office announced that economic growth in the Eurozone increased, rising 0.3%, improving from 0.1% in the previous quarter. This was the third quarter of growth since the end of an eighteen month recession. The Eurozone's recovery was the fastest since Quarter Two of 2011. The German economy grew by 0.4% in this quarter, rising from 0.3% in the previous quarter, with exports and capital investment helping the figures but household spending fell. The economy grew by 1.3% in 2013. The French economic data was better than expected with growth of 0.3% in the final quarter 2013, up from zero in the previous quarter. Over the whole year France's economy grew by 0.3%. The credit rating agency Moody's upgraded Ireland's debt from junk status to investment grade (from Ba1 to Baa3) stating the Irish economy having growth potential. The recovering economy and its improved growth potential along with its return to the international bond market were reasons for the upgrade.

#### 5 **Performance**

### Internally managed passive portfolio

5.1 The internally managed passive portfolio is modelled to track the index with a tolerance of †/.0.5% pa allowing for the costs of rebalancing. The figures shown below are for this part of the Fund only.

The figures for the whole UK equity portfolio show:

- The combined portfolio has outperformed its benchmark over the twelve month period by 2.62%
- Standard Life and AXA Framlington outperformed their benchmark by 8.69% and 7.63% respectively in the twelve month period to 31 March 2014 whilst Schroders underperformed their benchmark by 5.34%.

#### Three Year Analysis

Over the three year period AXA Framlington and Standard Life outperformed their benchmark by 4.64% and 1.62% respectively whilst Schroders underperformed its benchmark by 1.91%. The internally managed passive portfolio outperformed its benchmark by 0.09% but within its agreed tolerance.

### Five Year Analysis

Over the five year period all three external managers outperformed their benchmarks. AXA Framlington outperformed its benchmark by 5.99%, whilst Standard Life and Schroders outperformed their benchmarks by 3.59% and 2.30% respectively. The internally managed passive portfolio matched its benchmark over the period.

5.3 Each external manager's commentary is summarised below:

## **Schroders**

4th Quarter 2013/14

## **Performance**

During the quarter, the Fund returned 1.9% against the Small Cap benchmark of 2.1%. Over the twelve month period the fund returned 26.9% against its benchmark

of 32.3%. This underperformance reflected both the strong price moves in a number of recovery stocks and the inability of some companies held by the Fund to keep pace with such a fast moving market. Moss Bros was the largest contributor to performance as the new management team returned the company to growth. MJ Gleeson benefitted from the strong housing market while Pace, Dart and James Fisher announced trading results at the top end of expectations. Essenden has been transformed under new management with the shares nearly trebling during the period. Negatives to performance included Digital Barriers and Carclo who both suffered from a delay in orders for their products; Cohort who were caught up in the general sell off in defence stocks over budget concerns, despite announcing some very strong new orders; Future and Devro both had profit warnings while Arrow Global suffered in a general sell off in financials. The company remains on track to meet market expectations.

#### **Activity**

During the quarter, two new holdings were added. Dialight was bought but fell heavily after a profit warning. The company has a very strong position in the LED lighting market and has excellent long term growth potential. Sportech shares were bought and are well positioned to take advantage of the deregulation in the American gambling market. During the period holdings in Elementis, Oxford Instruments and Pace were sold to fund Dialight and Sportech and some of the existing holdings in the fund.

### Outlook and Strategy

The focus remains on investing in well financed companies with strong market positions that can continue to increase their selling prices. As the confidence of companies continues to increase a return to corporate activity is expected as their substantial cash balances are put to use. The performance of 29.12% over the longer term has been strong compared to the benchmark of 26.82%.

### Standard Life

4th Quarter 2013/14

#### Performance

During the quarter, the fund returned 0.6% against the FTSE All Share index return of -0.6%. Over the year to 31 March 2014, the fund returned 17.5% against the index return of 8.8%. Foreign & Colonial Asset Management was a notable contributor to performance, as the shares approached the takeover price offered in the bid by Bank of Montreal. Regional airline flybe also featured strongly after investors responded well to a capital increase designed to restore its balance sheet and reposition the airline for further growth in the UK. Shares in International Consolidated Airlines also outperformed, as fresh cost cutting announcements at its Iberia brand improved profitability. Negatives to performance included shares in Barclays which weighed on performance as weaker fixed interest, currency and commodity trading affected the investment banking division's performance. Shares in bookmaker William Hill also declined after indications that the government would bow to pressure to increase regulation on lucrative fixed-odds betting terminals. Sainsbury shares fell in response to negative same-store sales data and an increasingly competitive trading environment.

#### **Activity**

The fund purchased shares in support services company Interserve during a capital increase designed to part fund the acquisition of Rentokil's facilities services business, which will bring good operational and cost benefits. Shares in Burberry were purchased after weakness related to emerging market currency concerns and disappointing guidance. The benefits from overhauling back office systems, distribution and stock replenishments should drive up sales and margins. Shares in Prudential were added to the fund following a positive meeting with management.

The holding in Verizon Communications, acquired as part of Vodafone's sale of Verizon Wireless, was sold during the quarter as the company is US listed and does not form part of the UK benchmark. Resolution was also sold due to concerns over the regulator's pending review of charges related to historic policies and closed funds and following measures in the budget which makes the purchase of pension annuities optional.

### Outlook and Strategy

Investors are likely to be increasingly selective as valuations are now at more reasonable levels. Therefore, a greater focus on those attractively valued businesses demonstrating sustainable earnings growth is likely. In addition, some areas of the market have been overlooked in the recent rally, with certain emerging market-related equities in particular offering strong upside potential when sentiment towards those regions improve. Selected consumer and economically sensitive stocks continue to demonstrate value and with ample investment opportunity the environment will remain positive for equity investors as 2014 progresses. Areas in value lie in overlooked sectors such as property and mining, as well as airlines and engineering. Balance sheet strength should allow further upside for those companies able to increase dividends and add growth via acquisitions as companies increasingly concentrate on return on capital metrics.

## **AXA Framlington**

4th Quarter 2013/14

### Performance

During the quarter, the fund returned 1.0% against the FTSE All Share Index return of -0.6%. For the year to 31 March 2014 the fund returned 16.4% against its benchmark of 8.8%. Positives to performance included Ashtead Group, which was the biggest contributor to performance as the recovery in the US housing and construction became more apparent; Weir Group, where the share price improved further as US shale activity recovers; industrials, including support services which was the best performing sector and financials performed well. Xaar was the biggest negative influence to performance as the growth slowed in the first half of 2014, but the longer term attraction remains and being underweight in big oil was a negative in the oil and gas sector.

#### Activity

A holding of Poundland was purchased in the initial public offering. Holdings were added to included AstraZeneca, Aviva, BT, Royal Dutch B, Lloyds Banking Group and IMI. The Verizon shares received from Vodafone sale of Verizon Wireless were sold. Mulberry was also sold after a change of management and profit warning.

### Outlook and Strategy

Strong GDP growth in the UK is a good background for UK equities and a slow global recovery will help growth of earnings and dividends.

### 6 Review of Activity

- 6.1 There has been four significant corporate action in the six month period to 31 March 2014.
  - In October, the Eurasian Natural Resources Corporation Plc was involved in a Scheme of Arrangement by Eurasian Resources Group BV for £0.1M;
  - In January, Invensys Plc was acquired by Schneider Electric (France) for £0.9M
  - In February, a consolidation of Melrose Industries Plc took place at £0.1M

- In February, Vodafone sold its US Group (whose principal asset is its
  45% stake in Verizon Wireless) to Verizon Communications. After the
  sale Vodafone paid out \$82.5 Billion to shareholders and consolidated its
  shares, cutting its market value to about £60 Billion. Its value was £116
  Billion based on January's twelve year high price of £2.40. Dorset sold its
  Verizon shares and received four payments totalling £9.2M making a
  profit of £1.5 Million.
- The portfolio was rebalanced twice in the six month period to March 2014. In October, the total value of purchases and sales were £6.9M with a net sale of £0.4M. There were 22 purchases (£3.2M) and 77 sales (£3.6M). In January, the total value of purchases and sales were £4.3M with a net purchase of £0.5M. There were 26 purchases (£2.4M) and 48 sales (£1.9M).

### 7 Stock Lending

- 7.1 Stock lending is managed in the UK on an agency basis by HSBC, and overseas on the same basis by Pictet.
- 7.2 Total overseas stock lending income for the year to 31 March 2014 is £64,674. Net income for UK stock lending was £138,435 over the same period, giving a total of £203,109. This compares to the period to 31 March 2013 where overseas stock lending was £75,051 and the UK stock lending figure was £142,140, giving a total of £217,191.
