The purpose of the mental health review is to inform mental health practice and service development using the CCG Mental Health Acute Care Pathway as a reference point for discussion. The outcomes will be focused on person centred interventions and service users will be invited to contribute to the workshop. The review will look at the experiences of people who use services as well as professionals from participating agencies and backgrounds to understand what is working well and what is not. The workshop will include a presentation from the Clinical Commissioning Group on the Mental Health Acute Care Pathway and findings from the co- production on the plan with service users. The corporate plan outcomes are very clearly promoting safety, healthy living and supporting independence.

Mental health is a priority area for the council and there is a need to take stock of the current services and practice in light the CCG review and increased use of the Mental Health Act 1983. Mental health integrated working is highlighted as a priority within the Better Care Fund Plan for the Health and Well Being Board.

The review will inform service and practice developments promoting person centred approaches including recovery and supporting people into work and independence. Supporting the implementation of the Mental Health Acute Care Pathway should reduce the increasing demand for Acute Hospital provision by developing alternative crisis support services. Input from people who have experienced services should improve the effectiveness of interventions.
