### 1. Background to the Petition Scheme

- 1.1 The County Council's Petitions Scheme was adopted on 29 April 2010 and came into effect on 15 June 2010. The Scheme was subsequently updated by the County Council on 21 July 2016.
- 1.2 If a petition is supported by 50 or more signatories then it will be dealt with by a small customer focussed panel. If a petition is supported by 1,000 or more signatories it will be scheduled for a debate at the next meeting of the full County Council.

### 2. Petition – Parking in Meadowlands Estate, West Bay

2.1 The County Council received a petition organised by Ann-Marie Knox. This reads as follows:

"We wish to petition Dorset County Council to urgently include the Meadowlands Estate, West Bay, in its plans to restrict car parking in the area. The problem has become out of control to the point that emergency vehicles cannot access if needed due to the number of visitors parked cars along Meadowlands, Buttercup Way and Bramble Drive. We ask that Dorset County Council restricts parking on these roads to residents and provide visitor permits".

- 2.2 As this petition contains more than 50 signatures, the Panel are invited to note and discuss this.
- 2.3 This discussion should conclude with a decision as to how to respond to the petition. This may include one or more of the following:
  - taking the action requested in the petition
  - · considering the petition at a council meeting
  - holding an inquiry into the matter
  - undertaking research into the matter
  - holding a public meeting
  - holding a consultation
  - referring the petition for consideration by the council's audit and governance committee
  - calling a referendum
  - writing to the petition organiser setting out our views about the request in the petition.
- 2.4 Alternatively, the Panel may determine a combination of the options above, or decide on another course of action as appropriate.

### 3. Context

3.1 The Meadowlands Estate is a relatively new residential estate built in 2004 just off the main road to West Bay. There are no parking restrictions within the estate other than at the entrance. There is a public footpath that runs through the estate that leads all the way to

West Bay which is a popular walk. Vehicles park within the estate to make use of the decent walk into Bridport or West Bay (see appendix C photos). Bridport Town Council have been asked to support the introduction of parking restrictions in the estate – they are concerned that if yellow lines were introduced the parking issues would just move further into the estate. They also have to prioritise the list of proposed restrictions within their remit and feel that restrictions introduced in other areas would have the most impact for improvements for the town. Parking in Meadowlands is likely due in part, to a shortage of parking around the bay particularly in the summer, this is being investigated by West Dorset District Council and Bridport Town Council who are looking to increase parking areas.

It is important to consider that this parking restriction request is one of close to 120 other requests for a new Traffic Regulation Order across the whole of Dorset and it does not rank highly against other requests.

3.2 Collision data available to the County Council is provided and validated by Dorset Police. It includes collisions that occurred on the public highway reported to the police that resulted in personal injury to any person(s) involved.

It is accepted that this data is not the complete picture of collisions that have occurred however, it is the most robust and reliable data available to the County Council. It is standard practice to assess the most recent five year period of collisions when considering/identifying safety schemes.

Between June 2012 and May 2017 there have been zero injury collisions recorded in the Meadowlands Estate.
