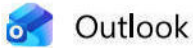

Dear Kathryn,

Thank you for your email, I would like to send you some further objections for this licence application and to notify you unfortunately we are unable to attend the Hearing on Friday 25th at 1.30 PM at the Council Offices Dorchester.

1. Ms Karen Bailey and the leaseholder [REDACTED] are applying for a licence for up to 50 people, these premises are too small for 50 people and would also swamp the Courtyard area. Ms [REDACTED] does not rent the Courtyard area, it is only to be used as access to and from her shop which applies to all the other Shops and Flats in the Courtyard (Quarterjack Mews).
2. The terms of the lease for 6 Quarterjack Mews states (The Tenant must not obstruct or place any items for sale on any pavement, footpath or roadway adjoining or serving the property). it also states that the tenant needs to get the landlord's permission for change of use to the shop and the tenant has not applied for permission to turn the shop into a bar with music.
3. The previous event held at 6 Quarterjack Mews used microphones, and tenants from the flat above complained to the the organisers about the noise.
