# THE LICENSING ACT 2003 (HEARINGS) REGULATIONS 2005

## Rights of a Party

- 1. A party has the right to attend the hearing and may be represented by any person.
- 2. A party is entitled to give further information where the authority has asked for clarification.
- 3. A party can question another party, and/or address the authority, with consent of the authority.

#### Failure to Attend

- 4. If the authority is informed a party does not wish to attend, the hearing may proceed in their absence.
- 5. If a party has not indicated their attendance and fails to attend the hearing may be adjourned if considered in the public interest, or hold the hearing ensuring the party's representation is considered.
- 6. Where the authority adjourns the hearing it shall notify the parties of the date, time and place.

#### Procedural Information

- 7. At the start of the hearing, the authority shall explain the procedure which it proposes to follow and shall consider any request for permission for another person to appear at the hearing.
- 8. A hearing shall take the form of a discussion led by the authority and cross-examination shall not be permitted unless the authority considers that it is required.
- 9. The authority will allow the parties an equal maximum period of time in which to speak.
- 10. The authority may require any person behaving disruptively to leave, and may refuse that person to return, but such a person may, before the end of the hearing, submit in writing information they would have been entitled to give orally had they not been required to leave.

#### **FOOTNOTE:**

In relation to all other matters governed by the Licensing Act 2003 (Hearings) Regulations 2005 any party or their representative may contact the Licensing Services at Dorset Council and they will be provided with a full copy of the regulations on request.

#### LICENSING SUB-COMMITTEE PROCEDURE

- 1. At the start of the meeting the Chairman will introduce:
  - the members of the sub-committee
  - the council officers present
  - the parties and their representatives
- 2. The Chairman will then deal with any appropriate agenda items.
- 3. The Licensing Officer will be asked to outline the details of the application, including details of any withdrawn representations.
- 4. The applicant or their representative is then invited to present their case.
- 5. Committee members will be invited to ask questions.
- Where appropriate the Responsible Bodies e.g. representatives of Police, Fire Services, Environmental Services or Trading Standards will be invited to address the sub-committee on any relevant representations they may have.
- 7. The Chairman may then allow an opportunity for questions.
- 8. The Chairman will ask any person who has made representations, who have already expressed a wish to do so, to address the sub-committee. The sub-committee will have read all the papers before them, including any letters of representation. Members of the public are asked to keep their comments concise and to the point.
- 9. All parties will be given the opportunity to "sum up" their case.
- 10. The Chairman will ask the Legal Advisor if all relevant points have been addressed before advising all parties present that the sub-committee will withdraw from the meeting to consider its decision in private. The sub-committee will be accompanied by the Democratic Services Officer and the Legal Advisor can be called upon to offer legal guidance.
- 11. On returning the Chairman will:
  - Notify all those present of the sub-committee's decision (or indicate when it will be made)

- Give brief details of any conditions attached to the licence approval;
   Or
- Outline the reasons for the refusal
- Inform that detailed reasons will follow in writing (unless given on the day)
- Inform those present of their right to appeal to the Magistrates' Court

#### NOTE

The Chairman may vary this procedure, as circumstances require but will have regard to the rules of natural justice and the Licensing Act 2003 (Hearings) Regulations 2005.

The meeting will take place in public. However, the public can be excluded from all or part of the meeting where the sub-committee considers that the public interest in so doing outweighs the public interest in the meeting or that part of the meeting, taking place in public.

Under no circumstances must the parties or their witnesses offer the sub-committee information in the absence of the other parties.

The Chairman and the Sub-Committee have discretion whether to allow new information or documents to be submitted and read at the meeting.

**Brief Summary:** An application has been made for a new premises licence for McDonalds in Weymouth. The application has been out to public consultation and has attracted relevant representations. A Licensing Sub-Committee must consider the application and representations at a public hearing.

**Recommendation**: The Sub-Committee determines the application in the light of written and oral evidence and resolves to take such steps as it considers appropriate and proportionate for the promotion of the licensing objectives of;

- a) The prevention of crime and disorder
- b) The prevention of public nuisance
- c) Public safety
- d) The protection of children from harm

**Reason for Recommendation**: The Sub-Committee must consider the oral representations and information given at the hearing before reaching a decision.

#### 1. Background

- 1.1 Section 4 of the Licensing Act 2003 sets out the duties of the Licensing Authority, it sets out that a Council's licensing functions must be carried out with a view to promoting the four licensing objectives of:
  - (a) the prevention of crime and disorder;
  - (b) public safety;
  - (c) the prevention of public nuisance; and
  - (d) the protection of children from harm.
- 1.2 All applications and decisions are made with due regard to the <u>Licensing Act 2003</u> (the Act), the <u>Revised Guidance issued under Section 182 of the Licensing Act 2003</u> (the Guidance) and the <u>Dorset Council Statement of Licensing Policy</u> (the Policy).
- 1.3 The relationship between planning and licensing is set out in paragraphs 6.2 to 6.5 of the Dorset Council Policy: -

The use of premises for the sale or provision of alcohol, regulated entertainment or late-night refreshment is subject to planning control. Such use will require planning permission or must otherwise be lawful under planning legislation. Planning permission is generally required for the establishment of new premises or the change of use of premises.

In line with the S182 Guidance the planning and licensing regimes involve consideration of different (albeit related) matters. Licensing committees are not bound by decisions made by a planning committee, and vice versa.

Where businesses have indicated, when applying for a licence under the Act, that they have also applied for planning permission or that they intend to do so, licensing committees and officers will consider discussion with their planning counterparts prior to determination with the aim of agreeing mutually acceptable operating hours and scheme designs.

Where relevant representations are received, any decision on a licence application will not consider whether any decision to grant or refuse planning permission or building consent was lawful and correct. It will take into account what the impact of granting the application will be on the four licensing objectives.

# 2. **Details of the Application**

- 2.1 McDonalds have applied for a premises licence at McDonalds, 2 Souterway, Weymouth.
- 2.2 The description of the premises within the application form is: -
  - "Restaurant selling food and non-alcoholic drinks for consumption on and off the premises"
- 2.3 The full application and the operating schedule, as received, are attached at Appendix 1. The site location can be viewed at Appendix 3 this has been taken from the council's Dorset Explorer page, showing the proximity of nearby residential properties. The plan of the premises, as received, are at Appendix 2.
- 2.4 The application is to permit: -

## **Late-night refreshment (Indoors)**

Everyday 23:00 – 05:00

# 3. Representations from Responsible Authorities

3.1. Section 13 of the Licensing Act 2003 contains the list of Responsible Authorities who must be consulted on each premises application. Dorset Police, Dorset and Wiltshire Fire Service, Public Health Dorset, the Immigration Authority, Dorset Council Trading Standards, Dorset Council Planning Department, Dorset Council Children's Services and Dorset Council Health and Safety Team have all been consulted and offered no representations or comments on this application.

# 4. Representations from Other Persons

- 4.1. 21 representations have been received from members of the public and 2 representations from local ward members. All the representations are expressing objections to the application, and these are included, in full, at Appendix 4. Most of the representations received made comment on the need for this kind of store in the area for the times requested, anti-social behaviour linked to the sale of late-night refreshments, litter and noise that would emanate from patrons in their vehicles. The concerns of need or increased traffic would have been concerns for the planning process which would have been taken into consideration during the planning application for the premises which the planning authority granted. The matters concerning anti-social behaviour and litter must be taken into consideration under the procedures as set out in the Licensing Act 2003.
- 4.2. The Guidance sets out at 8.13 the role of "other persons": -

"As well as responsible authorities, any other person can play a role in a number of licensing processes under the 2003 Act. This includes any individual, body or business entitled to make representations to licensing authorities in relation to applications for the grant, variation, minor variation or review of premises licences and club premises certificates, regardless of their geographic proximity to the premises. In addition, these persons may themselves seek a review of a premises licence. Any representations made by these persons must be 'relevant', in that the representation relates to one or more of the licensing objectives. It must also not be considered by the licensing authority to be frivolous or vexatious. In the case of applications for reviews, there is an additional requirement that the grounds for the review should not be considered by the licensing authority to be repetitious. Chapter 9 of this guidance (paragraphs 9.4 to 9.10) provides more detail on the definition of relevant, frivolous and vexatious representations.

4.3. The guidance states at paragraph 9.4 what a "relevant" representation is;

"A representation is "relevant" if it relates to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives. For example, a representation from a local businessperson about the commercial damage caused by competition from new licensed premises would not be relevant. On

the other hand, a representation by a businessperson that nuisance caused by new premises would deter customers from entering the local area, and the steps proposed by the applicant to prevent that nuisance were inadequate, would be relevant. In other words, representations should relate to the impact of licensable activities carried on from premises on the objectives."

#### 5. Considerations

5.1 Paragraphs 9.42 to 9.44 of the Section 182 Guidance sets how the Authority should decide what actions are appropriate.

"9.42 Licensing authorities are best placed to determine what actions are appropriate for the promotion of the licensing objectives in their areas. All licensing determinations should be considered on a case by-case basis. They should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be.

9.43 The authority's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve.

9.44 Determination of whether an action or step is appropriate for the promotion of the licensing objectives requires an assessment of what action or step would be suitable to achieve that end. While this does not therefore require a licensing authority to decide that no lesser step will achieve the aim, the authority should aim to consider the potential burden that the condition would impose on the premises licence holder (such as the financial burden due to restrictions on licensable activities) as well as the potential benefit in terms of the promotion of the licensing objectives. However, it is imperative that the authority ensures that the factors which form the basis of its determination are limited to consideration of the promotion of the objectives and nothing outside those parameters. As with the consideration of licence variations, the licensing authority should consider wider issues such as other conditions already in place to mitigate potential negative impact on the promotion of the licensing objectives and the track record of the business. Further advice on determining what is appropriate when imposing conditions on a licence or certificate is provided in Chapter 10. The licensing authority is expected to come to its determination based on an assessment of the evidence on both the risks and benefits either for or against making the determination."

#### **Operating Schedule**

#### General

This restaurant understands that in extending our opening hours we have a duty to the local community and that we continue to protect our staff and customers from danger and harm. We believe that the systems we have in place are robust, thorough and will, as far as reasonably practicable, secure the promotion of the four licensing objectives. It should be noted that no McDonald's restaurant within the United Kingdom serves alcohol and further none of our drinks or food are served to customers in glass receptacles.

We are eager to work in partnership with all responsible authorities to ensure the promotion of the four licensing objectives. We also seek to work with the local communities, whom we serve, in achieving a successful cohesion between our business operations and our neighbours.

#### Prevention of Crime and Disorder

This restaurant is keen to work in partnership with the local police service to prevent crime and disorder.

#### **CCTV**

McDonald's operates a robust CCTV Policy to ensure compliance with Data Protection Legislation and to assist the Police with the prevention and detection of crime. At all stores where CCTV is in operation appropriate signage reflecting this information is displayed.

McDonald's operate digital motion activated CCTV systems where images are retained on a hard drive system. All CCTV equipment is of a standard suitable to record images of a proper quality, it meets the industry standard and has LGC Forensics or Kalagate Certification. As part of the digital system an alarm will sound if the equipment is faulty or not recording, thereby alerting management for the need to intervene. The CCTV system is regularly serviced by qualified maintenance technicians.

Access to the CCTV system will be provided to Police Officers at their request.

#### Staffsafe

A Staffsafe™ system with both audio and visual monitoring capability will be installed in the restaurant, this system, can be activated by either fixed or mobile panic buttons. Once activated the system links the restaurant to an external monitoring centre capable of intervening to resolve crime and disorder issues and/or provide the appropriate advice or instruction to support and protect the restaurant's staff and customers.

At this restaurant all shift managers have safety and security training; including Maybo SIA accredited Conflict Management Training.

#### Public Safety

This restaurant is keen to work in partnership with the local Fire Service and Environmental Health Officer to ensure public safety.

This restaurant has safety systems in place to protect the safety of customers and staff at all times (such as Staffsafe). We work with the local Environmental Health Office and local Fire Service to ensure we are complying, as far as reasonably practicable, with relevant Health and Safety and Fire Safety Legislation. This restaurant is also subject to inspections from our own safety and security teams to ensure our systems are being maintained.

All of our restaurant staff receive comprehensive safety training to ensure that safe working methods are adopted and all staff are trained on the restaurant's evacuation procedure in the event of a fire or other dangerous occurrence.

This store operates a "No Open Alcohol Containers" policy to prevent persons carrying open alcohol into the in-store area.

#### Public Nuisance

#### Litter

McDonald's were the first company in our sector to introduce litter patrols in the early 1980's. McDonald's is committed to carry out litter patrols collecting both McDonald's packaging and any other litter that has been carelessly discarded. We are happy to act on recommendations from the Environmental Health Officer should they feel that we should extend our patrol to a nearby area, as far as this is reasonably practicable.



#### Noise



As a resident of Hetherly Road I find the lack of openness and communication incredibly worrying and frustrating. Why was a letter not sent out to immediate neighbours who would be impacted by this? Very poor indeed.

I have a couple of questions

- 1) How can you consider extending the hours when the business is not even up and running in order to know the impact the approved trading hours will already have, let along extended? This in itself surely makes this impossible to improve as you have no evidence of approved hours and the impact that has on residents.
- 2) Is this the way businesses get what they want? They have not long since received planning approval, the building is not even constructed yet they are applying for an extension of the trading hours! How do they know this is needed? Is this a loophole? Your planning department didn't allow it to become a 24 hour business so if you do there is something seriously wrong with the systems and processes within the council.

Please refuse this, you will turn living here into a nightmare for my family and I. You only have to read of other people experiences of living near to a McDonalds to see this has a detrimental impact on peoples lives, mental health and their homes.

	Thank you for sending in Weymouth.	your letter of representation for the premises licence at McDonalds,

Under the licensing act 2003 the only requirement for advertising is the responsibility of the applicant, they have to have blue notices displayed at the premises and also to have this advertised in a paper local to the area. There is no scope to write to immediate neighbours as anyone can make a representation to a premises licence application regardless of proximity.

All representations must relate to one or more of the four licensing objectives and these are; -

- Crime and Disorder
- Prevention of Public Nuisance
- Protection of Children from Harm
- Public Safety

Any matters concerning highways, be this traffic levels or parking, will not be considered in the decision process this would have needed to of been raised at the time during a planning application for the site. Planning consult with Highways in relation to planning applications but Highways are not a responsible authority under the licensing act 2003, these applications are not consulted with the Highways authority.

The needs of whether the area requires another store like this is another thing that will not be considered, again this would have been a planning policy matter, this concern would not fall under one of the four licensing objectives.

If after the planning process the planning authority had granted the application with a condition restricting its times then the applicant even though applying for a 6 hour licence would not be able to use it due to a planning restriction. Upon looking at the planning decision no restriction on times was implemented on the development. However the planning authority are a consultee so if there any restrictions and I have looked in the wrong place then they will make a representation stating this.

An applicant can apply for such licence even if there was no building in place to physically use, in most cases a development like this would most likely get everything it requires in place before it opens, this would be things like the planning application and if needed a premises licence application. There is no right or wrong answer as to when they apply for the premises licence but they are more than legally allowed to do so before the building has been built.

As we have received your letter of representation what will happen next is after the end of the consultation period of 28 days we will arrange a committee hearing, where all those who have made a representation along with the applicant will be invited, the committee will take place at County Hall, Dorchester.


The committee hearing will be run by the Licensing Sub-Committee which is tabled by three councillors of Dorset council. All parties involved will be given an opportunity to speak to amplify what they have originally said in their representation. The decision will be down to the Licensing Sub-Committee and they have a selection of options that they could take and these are:

- a) to grant the licence subject to such conditions as the authority considers appropriate for the promotion of the licensing objectives, and the mandatory conditions
- b) to exclude from the scope of the licence any of the licensable activities to which the application relates;
- to refuse to specify a person in the licence as the designated premises supervisor; c)
- d) to reject the application.

As a local resident with a house ( abutting the Weymouth Gateway site, I object to the granting of a late night premises licence to Mc Donald's at 2 Souter Way.

There is a great deal of documented evidence of problems arising from premises serving refreshments and food in the hours between 23.00 and 0500 hours and sadly I would forsee these same problems arising at 2 Souter way

The points I would like to make are as follows:-

#### Antisocial human behaviour

After 23.00 hrs many of the customers attracted to the Mc Donald's product have already spent some time imbibing alcohol in licensed premises. This of course leads to certain behaviour patterns which tend to be loud, boisterous and sometimes aggressive. This anti-social behaviour creates a public nuisance for those living in the vicinity. Without a late night Mc Donald's the Weymouth Gateway development could be relatively quiet after retail outlets have closed for the evening.

#### **Ant-social vehicle issues**

Because of its out-of-town position, most of the potential late night Mc Donalds customers would be arriving there by car. In the past, during Lockdown, Mercery Road was witness to anti-social "show off driving" in the form of cars driving at excessive speed, making excessive noise and using Mercery Road as part of a Weymouth race/rally track. The Police had to be made aware of this and were notified on many occasions. A late night Mc Donald's could only exacerbate this situation.

#### **Environmental Pollution**

Because of the Take- Away nature of the McDonald's product, the packing has become a well recognised Environmental issue. Mc Donald's packaging is a common sight within a certain "eating distance" of their Drive thru restaurants and although Mc Donald's have a policy of collecting litter, it is by no means effective enough and is only carried out occasionally and in the immediate vicinity of the premises.

#### Suggestions of how these issues might be mitigated

If a late night license for Mc Donald's is a necessary requisite for the Weymouth public, then it would be more fitting to grant it to the existing mc Donald's premises at Jubilee Sidings, near the Travel Hub of Weymouth Railway station and Bus Hub. being near the town centre would mean that the Police could supervise more easily with late night trouble spots all in the same vicinity

To encourage responsible disposal of packaging materials that it be mandatory for the Mc Donalds operatives to write the vehicle registration number on the packaging so that the litter can be traced back to the perpetrator and suitable fines imposed.

I hope you will take these points into consideration and choose not to grant a late night licence to the Mc Donald's restaurant at 2 Souter way weymouth.

With respect to the recent application from McDonalds for the extension of opening hours from 2300 to 0500 for their new franchise at the Weymouth Gateway site, I submit the following objections that are based on a wealth of evidence from other areas near to existing McDonalds' outlets (and other late-night food outlets) in the UK, including McDonalds at Jubilee Close Retail Park, Weymouth (1 mile away):

- Constant litter. Although it is recognised McDonalds attempt to clear some of this from time to time in the near vicinity of their outlet, these efforts are insufficient to continually manage the problem near to and further from the majority of McDonalds outlets in the UK.
- 2) Late night noise from individuals and vehicles, close to residential areas. There is ample evidence that gatherings of people (of all ages) late at night can, and does, lead to higher-than-normal noise levels and a <u>variety</u> of anti-social behaviour, including disorder and illegal activities. McDonalds' sites are not exempt from this and to a large extent act as catalysts for such behaviour.
- 3) A late night meeting place for young people and their vehicles, some of whom may not be customers of McDonalds, with the aim of demonstrating their driving skills (or not) and capabilities (or not) of their vehicles. Causing safety problems and noise issues late at night.

This has been a particular problem at the Jubilee Close Retail Park outlet that has resulted in some of the participants moving their activities to the Weymouth Park and Ride site, just a stone's throw from the new Weymouth Gateway outlet! At that location there has been at least one accident, causing serious injury to a young passenger. Police have been called to that site to deal with problems.

Mercery Road, within the Weymouth Gateway, already is often used as a late night "racetrack" by these individuals. The police are aware of these activities. Adding a late-night food outlet here will only increase the problem by providing the "racers" with an additional base, attracting more participants. Some of these new participants are likely to be attracted from out of town, possibly though social media, due to the convenient location of the Weymouth Gateway site to the A354 road into/out of Weymouth.

4) Late-night food outlets are considered beneficial for shift workers. However, there are other existing locations within a mile of Weymouth Gateway where such facilities are already available, not warranting an additional outlet.

I trust you will give my objections due consideration in reaching your decision on this subject that is of serious concern to local and other residents of Weymouth.

Dear Sir,

I would like to register my strongest objection to the proposed increased opening time for the McDonalds fast food outlet on Mercery Road.

My objections fall into the following areas.

#### Prevention of Public Nuisance.

We have suffered anti-social behaviour in the adjacent Park and Ride area since it opened. This ASB has got worse over the last two years. The cars arrive around 10.30pm just as people are preparing to go to bed and can continue until 1 or 2 o'clock in the morning. The noise of revving engines the screeching of tyres is horrendous and, in the summer, when people have their windows open it is even worse. The McDonalds outlet is also located in a bowl, the area being much lower that the surrounding residential areas and this amplifies the noise. The cars also race away from the P&R and you can hear them speeding all the way down the Weymouth Bypass to the Littlemoor roundabout to the north and Chafeys roundabout to the south.

Extending the opening hours in a residential area is going to make ours and our neighbours lives unbearable.

#### Crime and Disorder.

These types of food outlets with parking always attract large crowds of youngsters as can be seen down at the McDonalds site at the Jubilee Sidings. Any such gathering has the potential for crime and disorder. You only have to walk around the area, and you will see litter which has come from the outlets. This litter appears all the way down Radipole Park Drive as they throw the used packaging out of their car windows. This area is a bird sanctuary, and the plastic materials are a threat to their environment.

### Public Health and Safety.

I'm not sure if you are aware but Weymouth has been classified for at least the last five years as being in the lowest 10% of deprived areas in England. One reason for this is the growth of fast-food outlets and the accompanying low pay jobs that they provide. There are also statistics that show that over 18% of all Year 6 children are obese. As a responsible authority you should be looking for ways to reduce this deprivation and certainly not allowing increased opening hours.

Extending opening hours will add to this problem.

I'm also a light sleeper so when this ABS at the Park and Ride is going on I'm not able to sleeps. So, I get angry and frustrated which leaves me tired and irritable the next day which is not good for someone who suffers from high BP.

Extending the opening hours will bring this potential noise closer to my home.

#### Protection of Children from Harm.

As I've already said these types of outlets with plentiful parking attract large gatherings of young people with the potential for ASB and crime. These gatherings also include children under the age of 16 who think it's acceptable for such behaviour and through peer pressure also include children who probably would not behave in such a way if not for these gathering areas. If we are to stop ASB then it's the younger children, we should be trying to educate about what is right and what is wrong.

Also, you've mentioned in your letter to our Councillor that only the above four defined objectives will be taken into your assessment. However, the original Planning application would not have covered the extended opening hours and potential problems associated with this. Therefore, other issues such as noise from late night traffic and environment issues such as potential increase in smell and prolonging light pollution by the increased opening hours.

I also feel that one of your judgement objectives should include Need. Is there a need for further opening hours when there is already an existing McDonalds with late opening just over a mile away?

I trust that you will take my objections seriously and refuse this application.

Traffic and Noise Pollution ... this business will bring increased traffic and noise, so surely protection must be in place to limit the impact on local residents. It is paramount that there is no increase in traffic all through the night. Surely we have a right to a decent nights sleep, don't we?

Since this development has progressed we are already plagued with cars and motorbikes using this road as a rat run( boy racers are already an issue), this will increase dramatically with this proposal and hence will impact on our quality of life.

#### **Dear Licensing Team**

We wish to make an objection to the above application for late night provision of refreshment (11pm - 5am) at the above premises, taking in to account the following licensing objectives:

**Prevention of crime and disorder** - Whilst we acknowledge that McDonald's cannot be held responsible for the behaviour of the public once off the premises, we are very concerned about the level of anti-social behaviour that this establishment will attract. There is already an issue with antisocial/dangerous driving in the vicinity of Mercery Road and the Park and Ride site (sometimes until 2am in the morning), and granting a license for late night opening is only going to exacerbate the issues. The current situation in the area is already being investigated by Dorset Council and Dorset Police, who have been working hard to rectify the problems being experienced.

**Prevention of public nuisance** - Related to the above issue of antisocial/dangerous driving, residents are already kept awake late in to the night/early hours by screeching tyres, revving engines, and the bass from car stereos (which reverberates through our homes). Granting a license for late night opening is only going to exacerbate these issues, bringing it even closer to our homes than it is now, with drivers parking up with their takeaways and playing loud music/showing off their driving skills. The Summer months are approaching and, if past experience is anything to go by, we will again be unable to have our windows open on hot nights due to the amount of noise disturbance generated by antisocial behaviour.

We are also concerned about the amount of littering that is likely to be caused. Mercery Road is already full of litter and with 24-hour opening, this has the potential to be made worse. Although McDonald's supposedly carries out regular litter picks, you only have to walk down the back of Jubilee Retail Park (approx. 1 mile from Souter Way) to see that is strewn with McDonald's food packaging on most days.

**Protection of children from harm** - Again related to the above, many residents have young children who are at risk of sleep deprivation from the above-mentioned antisocial behaviour that is likely to be generated. Sleep deprivation is likely to affect their concentration and their ability to learn at school.

We would urge the Licensing Committee to please take our concerns in to account and reject this application for what will, in effect, be 24-hour opening of the premises. There is simply no need for another 24-hour McDonalds in Weymouth when there is already one very close by at Jubilee Retail Park.
