1. Apologies

Apologies for absence were received from Martin Longley and Cllr Byron Quayle.

Cllr Quayle was substituted by Cllr Cherry Brooks.

2. Election of Chairman

Cllr Somper was nominated by Cllr Flower and seconded by Cllr Brooks.

There were no other nominations for chairman.

Decision:

That Cllr Somper be appointed as Chairman of the Health and Wellbeing Board for the year 2023-24.

3. Election of Vice-Chairman

Patricia Miller was nominated by Cllr Somper and seconded by Cllr Flower.

There were no other nominations for vice-chairman.

Decision:

That Patricia Miller be appointed as Vice-Chairman of the Health and Wellbeing Board for the year 2023-24.

4. Minutes

The minutes of the meeting held on 15 March 2023 were confirmed and signed.

5. **Declarations of Interest**

No declarations of interests were made at the meeting.

6. **Public Participation**

There was no public participation.

7. Councillor Questions

There were no questions from councillors.

8. Urgent items

There were no urgent items.

9. Work Programme

The Board noted and discussed the work programme.

It was discussed that at future meetings individuals could be invited to the board to talk about items.

10. Better Care Fund 2022/23 Year End Template

The Head of Service for Older People, Prevention, and Market Access introduced the report and gave a short presentation which is attached to these minutes. The presentation included information on the End of Year Template, the performance against Better Care Fund metrics, and the development of the 2023-25 plan.

The Board discussed the following points:

- Support for carers and investment into carers casework.
- There were reductions in hospital delays.
- The introduction of a police operational model called Right Care, Right Person
- Aligning Better Care Fund reports so they are not retrospective.

Decision:

That the Better Care Fund 2022/23 Year End Template be retrospectively approved.

11. Pharmaceutical Needs Assessment: Supplementary Statement

The Consultant in Public Health introduced the report. The Pharmaceutical Needs Assessment was a statutory responsibility of the Board, and it was last published in October 2022. Changes to pharmacies had mainly impacted the BCP Council area, however further supplementary changes were expected.

Board members commented on the report and raised issues surrounding access to pharmacies due to staff shortages. A member felt it would be a good opportunity to bring the needs assessment together with clinical pharmacist commissioning work.

Proposed by Cllr Somper, seconded by Cllr Brooks.

Decision:

- 1. That the publication of the supplementary statement be approved.
- 2. That authority be delegated to the Director of Public Health to publish further supplementary statements as required.
- 3. That any supplementary statements published by the Director of Public Health be circulated to the Board for information.

12. Thriving Communities

The Director of Public Health introduced the report which set out a proposal to establish a project supporting place-based working in the Dorset Council area. The aim of the project was to grown community support and capacity through the VCSE sector to support people living well and independently.

Members commented on the report and the following points were raised:

- The direction of travel of the work will become clearer as it progresses.
- There were discussions between top level VCSE organisations and forward-thinking ICS's to support ICS's to thrive.
- The organisations on the Health & Wellbeing Board should be giving their collective support to this work.
- There would be involvement of people who were affected by this piece of work
- Proper engagement would need to be carried out.
- It is important to understand what works best for different communities.

Proposed by Marc House, seconded by Vivienne Broadhurst.

Decision:

- 1. That the use of £309k be approved to support this programme of work.
- 2. That the Health and Wellbeing Board oversee progress, provide leadership, and advocate for the access of the programme in the Dorset Council area.

Better Care Fund Year End Report 2022/23





The Better Care Fund – A Quick Reminder

- BCF is a key funding stream for all local systems
- ➤ In Dorset for 2022/23 it provided the Council and NHS with total of c£144m (which included late arrival of £4.5m via Adult Social Care Discharge Fund)
- > All BCF plans are co-produced between Council and Dorset NHS
- There are set mandatory conditions for investment of the monies and Performance Metrics
 - [™] ➤ BCF Policy Objectives echo our local shared priorities:
 - > Enable people to stay well, safe and independent at home for longer
 - Provide the right care, in the right place, at the right time
 - ➤ In addition to submitting annual plans for proposed spending, a year end summary is required. This was submitted under delegated authority on 23rd May, pending HWB approval today.



Our Performance against BCF Metrics

> Targets met for:

Avoidable Admissions & Discharge to Normal Place of Residence

Recent introductions of Immedicare, recovery focussed block contracted home care (RCR) and Trusted Assessor Service are key in enabling achievement.

Opportunities to broaden Immedicare to all care homes and extended to Home Care providers. RCR is a key area for future ICB/BCF investment.

> Target not met:

Rate of Permanent Admissions to Residential Care

- Like many other ICBs, care home placements were required on discharge due to lack of homecare during quarters one to three of 22/23
- Since the last 6 weeks of quarter four of 2022/23 there was an improving picture in homecare availability
- Home First Accelerator Programme in place; this will include improving reablement offer and optimise home care capacity

Below target for:

- Reablement Performance % of people who remained at home after 91 days following hospital discharge support by Reablement Target was 85%, actual was 79%
- Attributed to the Council's transfer of provision to new Local Authority Company - The pre and post transition period caused some difficulties in gathering data, which has led to reporting lower than expected performance.
- Care Dorset action plan in place. Performance at the end of quarter 4 of 2022/23 was rising to meet the forecast.
- Improvement expected for 2023/24.

What's Next for 2023-2025 Plan

- ➤ 2023-2025 Plan will be bought to the next HWB meeting; currently finalising initial planning activity as Dorset's ICB a 2 year planning round is opportunity to plan expansion of BCF
- ➤ Key focus on demonstrating how the Integrated Care Partnership, in particular Thriving Communities, links to the BCF
- > Priority areas for our planning and programme for 2023-2025:
 - ➤ Widening scope to All Age Commissioning; starting with All Age Carers development and joint commissioning arrangements to deliver Birth to Settled Adulthood
 - Additional investments in BCF around Home First / Intermediate Care
 - Budget building in line with new Schemes agreed
