ASB-related Public Spaces Protection Orders (PSPO), made under the Anti-social Behaviour, Crime and Policing Act 2014

What is the policy, strategy, project or service designed to do? (Include the aims, purpose and intended outcomes of the policy)

To protect public health and public safety from the adverse implications of antisocial behaviour. These can be classified as personal, nuisance or environmental, including physical and/or affecting mental health and wellbeing.

#### What is the background or context to the proposal?

Some of the previous district and borough councils had a range of legislative controls, including Public Spaces Protection Orders (PSPOs), to protect the public from the adverse effects of ASB by prohibiting certain actions and behaviours at specified locations. These have transferred into Dorset Council and are now due for review/renewal. Additional controls and locations are included in the proposed PSPO's.

#### Types of controls include;

- Restriction on consumption of alcohol in certain outside public areas
- Restriction on acting in an anti-social or disorderly manner in certain outside public areas
- Restriction on intentional feeding of gulls in certain outside public areas
- Restriction on aggressive begging in certain outside public areas
- Restriction on cycling along The Promenade, Weymouth
- Restriction on access Trinity Passage, Weymouth
- Restriction on unauthorised overnight camping in certain outside public areas
- Restriction on lighting of fires in certain outside public areas

The Orders will be in force for a period of 3-years at which time they will be due for statutory review.

Enforcement of the Orders by Police Officers/authorised officers is by fixed penalty notice at £100 to be paid within 28 days, £75.00 if paid within 14 days

Consultation has also taken place with the following organisations;

These organisations have control of relevant land or in the case of Dorset Police, responsibility for dealing with ASB in conjunction with the Council. DWFRS were consulted as the responsible fire authority in relation to the provision for fires on open land. They were consulted ahead of the public consultation.

What did this data, information, evidence and research tell you?

Data and service knowledge/information suggested that;

1. The most impacted protected characteristics are considered to be age and disability. Younger people have a higher likelihood of being involved in some types of ASB and/or complained about in relation to ASB. Mental health can give rise to behaviour interpreted as ASB.

Not at this stage although further information may be needed as implementation of the Orders proceeds and as part of the scheduled review.

A public consultation was undertaken with approximately 250 responses received. The consultation report is on the Council website.
