Good morning, Anthony

Thank you for your time yesterday afternoon, it was great to meet you and go through your very extensive paperwork!

As discussed, please see below the additional conditions that we would propose for your licence. They're obviously based on what you have agreed in your risk assessment with a couple of them removed after we went through them. These would be on top of the boxes you have ticked within the risk assessment which, as I explained, will become conditions too. If I've missed anything that you can remember, please let me know and I'll amend the below before forwarding it on to the Licensing Authority. If you're in agreement, I'd be grateful if you could reply with your acceptance of them so that this can be passed on with no objections from our perspective.

- The holder of the licence shall undertake a risk assessment with regards to the deployment of SIA Door Supervisors for any special events. This will determine whether it is appropriate to deploy door staff on those days and/or at any other time(s) and to then implement the outcome of the risk assessment. A copy of the risk assessment should be made available to an authorised officer of the Licensing Authority or Dorset Police upon request and for a period of up to 6 months.
- A risk assessment will be carried out with regards to the use of plastic or toughened polycarbonate (or similar) glasses. This will include for special events and all drinks will be served in plastic or toughened polycarbonate glasses after 2230hrs.
- All staff involved in the sale of alcohol shall receive training on the law relating to prohibited sales, the age verification policy adopted by the premises and the conditions attaching to the premises licence. Refresher training shall be provided at least once every 12 months. A record shall be maintained of all staff training and that record shall be signed by the person receiving the training and the trainer. The records shall be kept for a minimum of 12 months and made available for inspection by police, licensing or other authorised officers.

We agreed that the boxes you had originally ticked but after discussion, the ones we would like to now remove are:

CD27 All external fire exit doors shall be fitted with sensor alarms and visible or audible indicators to alert staff when the doors have been opened. *(Sensor alarms not fitted and no plans to, but fire exit and main entrance are fully visible from the bar area)*

CD40 As soon as possible, and in any event within one month from the initial grant of this licence, the premises shall join the local pubwatch or other local crime reduction scheme approved by the police, and local radio scheme, if such a scheme exists. *(The pub watch scheme is still in its infancy in Swanage and its longevity is not currently known, so agreed not to condition scheme membership but the invite to come along is most definitely still there and participation would be very much welcomed)*

CD48 Notices indicating the existence and effect of an Alcohol Designated Public Places Order will be prominently displayed at the exits to the premises. *(We don't believe that there is still a DPPO/PSPO relating to alcohol in the area so this is not relevant)*

CD49 The PLH/DPS will belong to a recognised trade body or Pub Watch Scheme where one exists, whose aims include the promotion of the licensing objectives. *(For the reasons mentioned above in CD40)*

PS13 A suitably trained First Aider or appointed person to deal with first aid issues will be provided at all times when the premises are open. *(Only one person is currently first aid qualified and cannot guarantee being on the premises at all times, so agreed this can be removed as a condition however more staff will be qualified anyway going forward)*

PS21-PS25 Relating to designated sporting events. *(Were unsure of the term "designated sporting event" but from research determined this related to live events happening in the premises instead of events being shown on the TV, so they are not relevant to this premises)*

Hopefully everything is agreeable, however if there is anything you'd like to discuss further, please do not hesitate to contact me. I look forward to hearing from you.
