With regards to your comment in relation to the consultation process, the Licensing Act 2003 requires an applicant to publish a notice in a local newspaper and to display a notice of A4 size on pale blue paper in a prominent position immediately on or outside of a premises for at least 28 days. The Act also states which responsible authorities the licensing authority must consult with: Police, Fire, Environmental Health, Planning, Child Safety, Trading Standards, Immigration and Public Health, we are not required to consult with Town and Parish Councils.

The Licensing Act 2003, also requires the licensing authority to publish a notice on their website, therefore, I would suggest regularly monitoring our webpage for any new or variation applications.

What we are doing however is sending out current applications (copies of the website) to ward members of Dorset Council, so a ward member should have been aware of this application so maybe you could ask them to keep you informed, this is something that out Team Leader is providing but this will not be extended to every Town and Parish Council in the Dorset Council area.

Regarding your request to extend, we cannot extend this consultation process because the Town Council were not aware of this until now. As mentioned, under Licensing Act 2003 regulations the consultation period is 28 days and this ends today, if we do not receive a representation from the Town Council by midnight tonight anything received after this time will not be included in any decision process.
