New premises licence application for Jurassic Fields, West Bay Fields, Bridport

Brief Summary: An application has been made for a new premises licence for Jurassic Fields, West Bay Fields, Bridport. The application has been out to public consultation and has attracted relevant representations. A Licensing Sub-Committee must consider the application and representations at a public hearing.

Recommendation: The Sub-Committee determines the application in the light of written and oral evidence and resolves to take such steps as it considers appropriate and proportionate for the promotion of the licensing objectives:

- a) The prevention of crime and disorder
- b) The prevention of public nuisance
- c) Public safety
- d) The protection of children from harm

The steps that the Sub-Committee may take are:

- a) to grant the licence subject to such conditions as the authority considers appropriate for the promotion of the licensing objectives, and the mandatory conditions;
- b) to exclude from the scope of the licence any of the licensable activities to which the application relates;
- c) to refuse to specify a person in the licence as the designated premises supervisor;
- d) to reject the application.

Reason for Recommendation: The Sub-Committee must consider the oral representations and information given at the hearing before reaching a decision.

1. **Details of the application**

1.1 An application has been made by Jurassic Field Productions Ltd, West Bay Fields, Bridport (What 3 Words: pepper.presumes.surface). The application plans and event safety management plan can be found at Appendix 1.

1.2 The description of the premises within the application form is:

“The premises consists of fields owned by the owners of Highlands End Leisure Complex. The premises is accessible via the slip road of the A35 Bridport Bypass access to Broomhills Farm and Bridport Recycling Centre. The layout of the site is shown in the EMP sent with the application. Alcohol is to be served from two locations in the area and consumption of alcohol will only be permitted within the event boundaries.

1.3 The application is for a one, three day event per calendar year to permit:

Live music (indoors and outdoors)

Friday 1400-2300 hours

Saturday 1100-2300 hours

Sunday 1100-2200 hours

Recorded music (indoors and outdoors)

Friday 1400-2300 hours

Saturday 1100-2300 hours

Sunday 1100-2200 hours

Performances of dance (indoors and outdoors)

Friday	1400-2300 hours
Saturday	1100-2300 hours
Sunday	1100-2300 hours

Supply of alcohol (on the premises)

Friday	1400-2300 hours
Saturday	1100-2300 hours
Sunday	1100-2200 hours

- 1.4 The Jurassic Fields event has been run, without incident, on their current site at Asker Meadows in Bridport every year since 2014. A copy of their current licence is attached Appendix 2.
- 1.5 Section 13 of the Licensing Act 2003 contains the list of Responsible Authorities who must be consulted on each premises application. Dorset Police, Dorset and Wiltshire Fire Service, Public Health Dorset, the Immigration Authority, Dorset Council Trading Standards, Dorset Council Planning Department, Dorset Council Environmental Protection, Dorset Council Children's Services and Dorset Council Health and Safety Team have all been consulted.
- 1.6 There were no representations received from any of the Responsible Authorities.
- 1.7 There was one representation received from a member of the public, expressing their objection to application in relation to noise. Their letter can be found at Appendix 3.
- 1.8 The event organiser wrote the interested party addressing their concerns. Their letter can be found at Appendix 4.
- 1.7 The Licensing Act 2003 Section 182 Guidance (the Guidance) sets out at 8.13 the role of "other persons": -

"As well as responsible authorities, any other person can play a role in a number of licensing processes under the 2003 Act. This includes any individual, body or business entitled to make representations to licensing authorities in relation to applications for the grant, variation, minor variation or review of premises licences and club premises certificates, regardless of their geographic

proximity to the premises. In addition, these persons may themselves seek a review of a premises licence. Any representations made by these persons must be 'relevant', in that the representation relates to one or more of the licensing objectives. It must also not be considered by the licensing authority to be frivolous or vexatious. In the case of applications for reviews, there is an additional requirement that the grounds for the review should not be considered by the licensing authority to be repetitious. Chapter 9 of this guidance (paragraphs 9.4 to 9.10) provides more detail on the definition of relevant, frivolous and vexatious representations.

- 1.8 The Guidance states at paragraph 9.4 what a "relevant" representation is:-

"A representation is "relevant" if it relates to the likely effect of the grant of the licence on the promotion of at least one of the licensing objectives. For example, a representation from a local businessperson about the commercial damage caused by competition from new licensed premises would not be relevant. On the other hand, a representation by a businessperson that nuisance caused by new premises would deter customers from entering the local area, and the steps proposed by the applicant to prevent that nuisance were inadequate, would be relevant. In other words, representations should relate to the impact of licensable activities carried on from premises on the objectives."

2 **Considerations**

- 2.1 Paragraphs 9.42 to 9.44 of the Section 182 Guidance sets how the Licensing Authority should decide what actions are appropriate.

"9.42 Licensing authorities are best placed to determine what actions are appropriate for the promotion of the licensing objectives in their areas. All licensing determinations should be considered on a case-by-case basis. They should take into account any representations or objections that have been received from responsible authorities or other persons, and representations made by the applicant or premises user as the case may be.

9.43 The authority's determination should be evidence-based, justified as being appropriate for the promotion of the licensing objectives and proportionate to what it is intended to achieve.

9.44 Determination of whether an action or step is appropriate for the promotion of the licensing objectives requires an assessment of what action or step would be suitable to achieve that end. While this does not therefore require a licensing authority to decide that no lesser step will achieve the aim, the authority should aim to consider the potential burden that the condition would impose on the premises licence holder (such as the financial burden due to restrictions on licensable activities) as well as the potential benefit in terms of the promotion of the licensing objectives. However, it is imperative that the authority ensures that the factors which form the basis of its determination are limited to consideration of the promotion of the objectives and nothing outside those parameters. As with the consideration of licence variations, the licensing authority should consider wider issues such as other conditions already in place to mitigate potential negative impact on the promotion of the licensing objectives and the track record of the business. Further advice on determining what is appropriate when imposing conditions on a licence or certificate is provided in Chapter 10. The licensing authority is expected to come to its determination based on an assessment of the evidence on both the risks and benefits either for or against making the determination.”
