Our library service is made up of:

- 23 council run libraries
- an online library service
- a home library service, which delivers services to housebound residents

This survey refers to the 23 libraries we run, not the eight community managed libraries that we support.

The first phase of our consultation [completed in January 2022](#). We received over 7,500 responses. By listening to your views, we have developed a draft strategy and our mission: To Inspire, Connect and Enable our communities through our services.

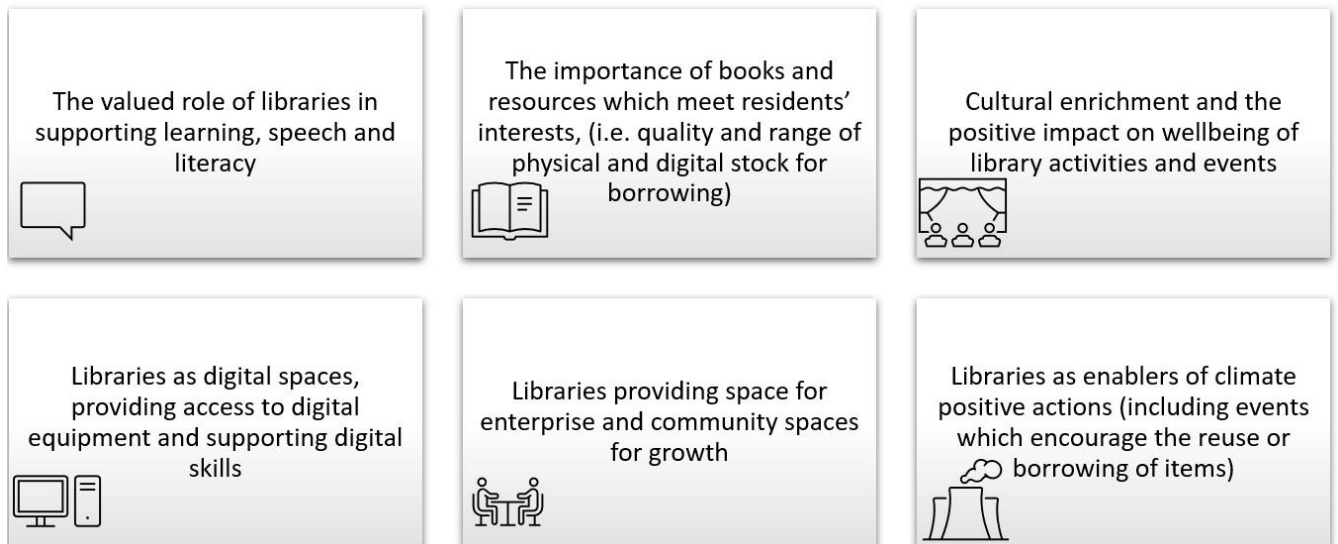

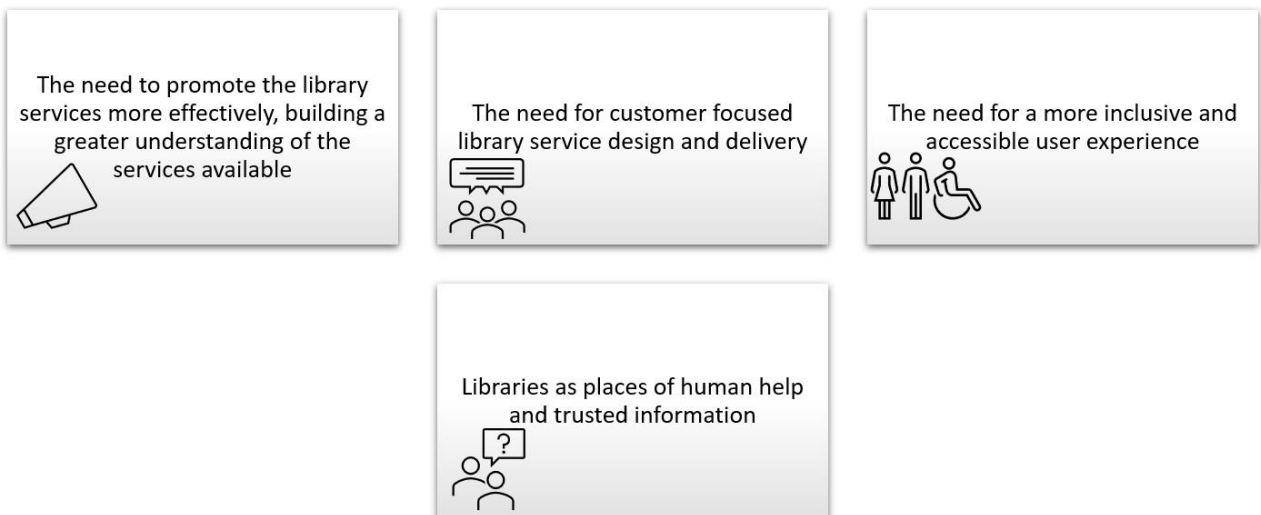

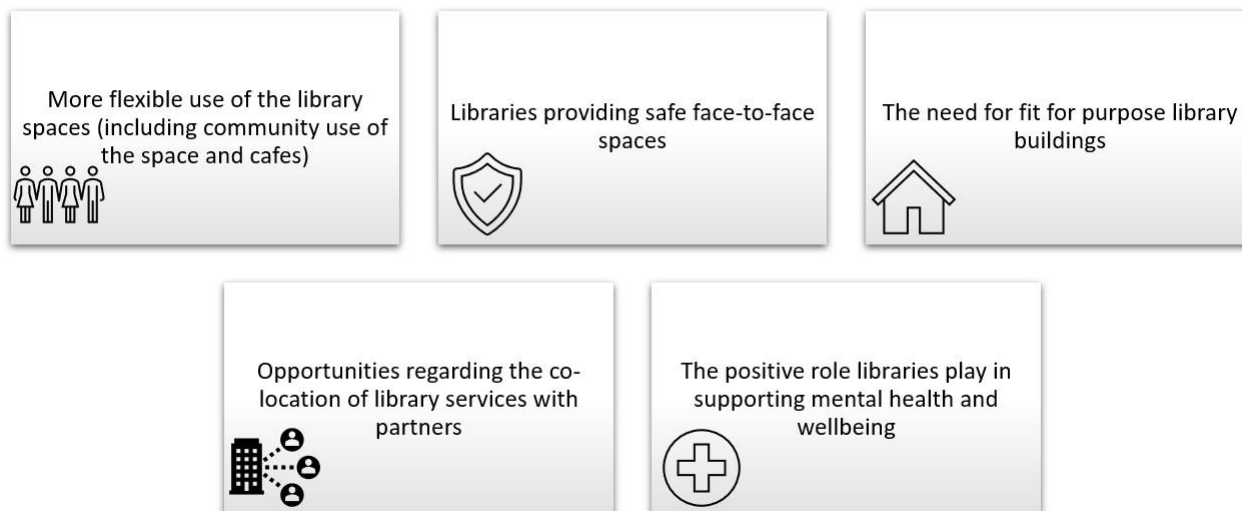

The vision was developed in collaboration with Let's Talk Libraries phase one consultees, library employees, Dorset Council services and Dorset Councillors.

Part two: help shape what delivery of the library strategy could look like in our communities

Our new library strategy will shape how we develop and deliver our Dorset Council run library services over the next ten years.

We have identified a range of services which the Dorset Council library service could deliver. Unfortunately we are not able to deliver all of these and we need to tailor what's possible in line with available resources and local need.

Dorset Council run libraries

We have drafted a new library model to inform how we could develop our service over the next ten years. We would like to seek your views on this.

We propose three types of Dorset Council run libraries:

1. **Library**

A library which delivers our core library offer

2. **Library +**

A library which delivers an enhanced core library offer

3. **Library Connect**

A library hub which delivers an enhanced core library offer including co-located partner services

Community Managed Library

Community managed libraries are a fourth type of library in Dorset. They are community led libraries, supported by Dorset Council. We have eight community managed libraries in Dorset, who provide library services in addition to the Dorset Council library service. We are not seeking feedback on this type of library. This survey seeks feedback on the proposed three types of Dorset Council run libraries.

Background: Community Managed Libraries

These libraries are run by volunteers from within their communities. The services available at these libraries are shaped by their management board and volunteers and responds to the needs of their communities. We support these libraries to deliver the following services:

- books and resources catering from early years to adults (including summer reading challenge resources)
- ability to browse, reserve and return stock from the Libraries West catalogue
- 24/7 access to e-resources (e-books, e-audiobooks, e-newspapers, e-magazines, e-comics)
- access to free WIFI
- access to free public access computers
- printing and scanning facilities (for a charge)

Core library offer

To improve customer experience, we want to be transparent and clear about what services are available at each type of Dorset Council library. Please note the services listed show what we aim to deliver during library opening hours. This does not prevent more flexible use of our library spaces after hours.

Library operating model

The draft strategy includes actions to standardise our operating model and opening hours. These will be informed by community needs, available resources and the financial constraints of the council.

Allowing our library services to be shaped by local needs is a key to developing our library service. This is supported by the Department for Digital, Culture, Media and Sport's Library Strategy for England. See the [Dorset Council Libraries Strategic Needs Assessment](#) for more detail.

We have developed draft operating principles for the three types of council run library. Please note we present a possible range of opening hours below. Your feedback will inform our future operating model, which will be decided upon following public consultation.

Library operating model: continued

The principles set out previously will inform how we develop our libraries over the next ten years. The needs of our communities may change and these operating principles allow us to react flexibly to meet need.

The first step is exploring how we could apply the new operating principles to our existing Dorset Council library network. We have analysed the level of community need for each library catchment to understand where need is greatest.

'Need' is determined by a range of measures which show need across all of society and an individual's lifetime. These include: population growth, educational attainment, health and wellbeing data, digital access and local economy.

We have combined community need with library demand data which generates an overall library catchment rank of need. This has allowed us to identify libraries in higher areas of need and those in relatively lower areas of need.

The table below presents a list of Dorset Council library catchment areas. A rank of 1 indicates greatest community need and 23 least community need.

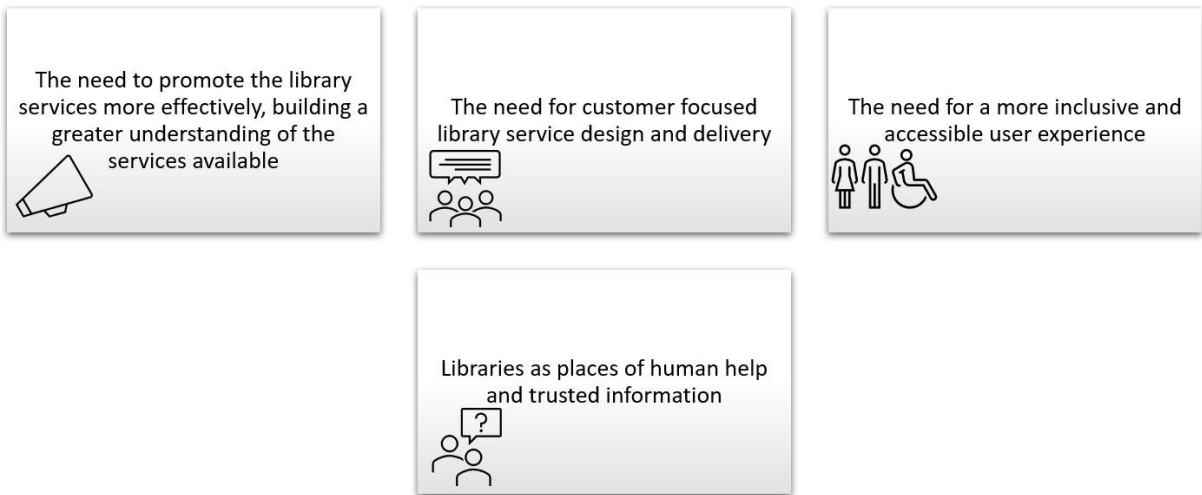

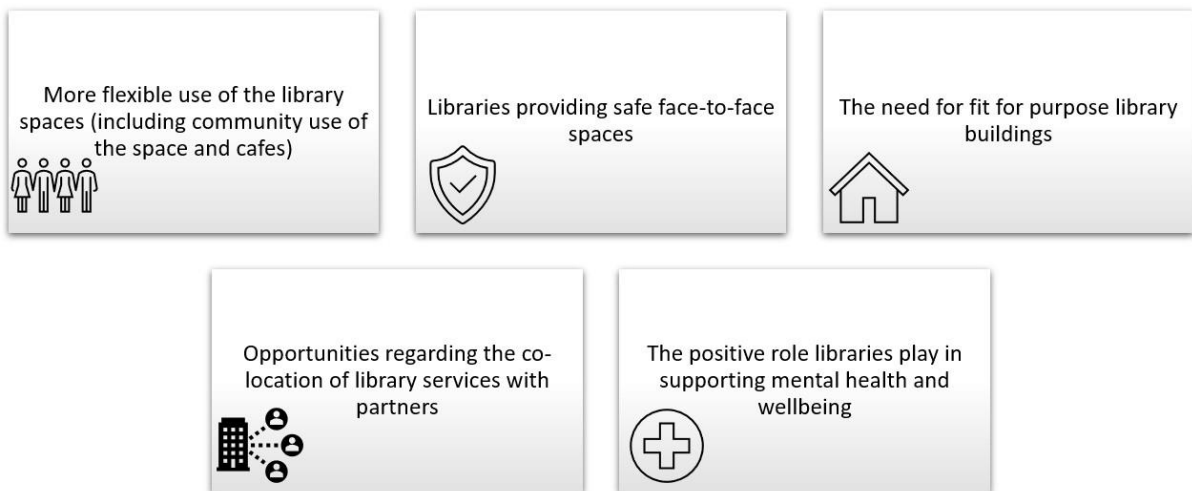

Library operating model: continued

The principles set out previously will inform how we develop our libraries over the next ten years. The needs of our communities may change and these operating principles allow us to react flexibly to meet need.

The first step is exploring how we could apply the new operating principles to our existing Dorset Council library network. We have analysed the level of community need for each library catchment to understand where need is greatest.

'Need' is determined by a range of measures which show need across all of society and an individual's lifetime. These include: population growth, educational attainment, health and wellbeing data, digital access and local economy.

Please see the [Dorset Council Libraries Strategic Needs Assessment for the full detailed analysis](#).

We have combined community need with library demand data which generates an overall library catchment rank of need. This has allowed us to identify libraries in higher areas of need and those in relatively lower areas of need.
