Please find below a representation from Weymouth Town Council regarding the application for a premises license for both 26 and 27 St Thomas Street.

This application has been considered by members of the Planning and Licensing Committee with the following comments:

- The cumulative impact zone policy is still in force. This is to stop any
 additional late night drinking venues in an area already affected by antisocial behaviour and public nuisance. The proposed bar is within the
 zone.
- Replying to both 26 and 27 St Thomas Street, these are adjacent properties, formerly used as a florist and a solicitor:



In the applications; no. 26 is described as a "day-time cafe", but the application is for a late licence Fridays and Saturdays for both premises? They have also put in timings for "recorded music" (we believe this would be a DJ). The times being applied for are until 2am on Fridays and Saturdays, until 11pm Monday - Thursday and 10pm on Sundays. The applicant hasn't put any non-standard timings in the application (e.g. bank-holidays/new years eve).

We note the applicant has an IDing policy, no under 18s after 7pm, and intend to join pub watch.

The Council objects on the grounds of:

No mention of CCTV being installed / what retention period to store video for – we believe the police will also require this. This should be required under Prevention of crime and disorder.

- Volume checks every hour is too weak, with single glazed windows (listed buildings), including residential above. If the applicants have amplified music, they should probably have a noise limiter under the Prevention of Public Nuisance.
- "Employing additional staff e.g. SIA" is too weak. If they trade after 11pm, then they must have a licensed SIA Door Supervisor on duty under Public Safety.

 We believe they have a sitting out area, we would like to see a condition that no outdoor drinking is permitted after 10pm. If people must go outside to smoke/vape, then the venue must control people's volume and display signs asking patrons to be quiet outside the venue, under Prevention of public nuisance.

Hello

The police and the applicant for the above premises have now had a meeting and have agreed to the following changes.

- The premises shall install and maintain a comprehensive CCTV system. The CCTV system shall continually record whilst the premises is open for licensable activities and during all times when customers remain on the premises. All recordings shall be stored for a minimum of 28 days with correct date and time stamping. A documented check of the CCTV shall be completed weekly to ensure all cameras remain operational and the 28 days storage for recordings is being maintained. A staff member from the premises who is conversant with the operation of the CCTV system shall be on the premises at all times when the premises are open to the public. This staff member must be able to show a Police or authorised Council officer recent data or footage with the absolute minimum of delay when requested. CCTV shall be downloaded on request of the Police or authorised officer of the Council. Appropriate signage advising customers of CCTV being in operation shall be prominently displayed in the premises.
- All staff involved in the sale of alcohol shall receive training on the law relating to prohibited sales, the age
 verification policy adopted by the premises and the conditions attached to the Premises Licence. Refresher
 training shall be provided at least once every twelve months. A record shall be maintained of all staff
 training and that record shall be signed and dated by the person receiving the training and the trainer. The
 records shall be kept for a minimum of 12 months and made available for inspection by Police, Licensing or
 other authorised officers.
- Challenge 25 shall be operated at the premises where the only acceptable forms of identification are recognised photographic identification, such as a driving licence or passport, or holographically marked PASS scheme identification cards.

- A log shall be kept detailing all refused sales of alcohol. The log shall be kept on the premises and shall be made available for inspection by the Police or an authorised officer of the Council at all times when the premises is open.
- The DPS will ensure that an incident report register is maintained on the premises to record incidents such as anti-social behaviour. The incident report register will be kept on the premises and produced for inspection immediately on the request of an authorised officer or Police.
- No children under the age of 18 will be allowed on the premises after 1900hrs.
- Glasses and glass bottles will not be permitted to be taken outside. Empty bottles and glasses will be collected regularly and promptly. Glass and other sharp objects will be stored and disposed of using tamper proof receptacles. Receptacles will be secured and not accessible to the customers.
- Prominent and clear notices/instructions are to be displayed at all relevant exit points instructing
 customers/staff to respect the needs of local residents and not to cause unnecessary noise when they leave
 the premises.
- There shall be a clear visible notice displayed on the premises advising those attending that the Police shall be informed if anyone is found in possession of controlled substances or weapons.
- The holder of the licence shall undertake a risk assessment with regard to the deployment of SIA Door Supervisors for special events and anticipated busy periods. The risk assessment will determine whether it is appropriate to deploy door staff on those days and/or at any other time(s) and the outcome of this assessment will be implemented. A copy of the risk assessment should be made available to an authorised officer of the Licensing Authority or Dorset Police upon request and retained on the premises for a period of up to 6 months.

As agreed, we would also like to see the terminal hour for the sale of alcohol and the opening of the premises brought back from 0200hrs to 0000hrs on Fridays and Saturdays.

I am required under the Licensing Act to ask if the above points have, or have not, alleviated your concerns and if you are now satisfied with the application. Due to the time constraints surrounding an application I would be grateful if you could please let me know by 14 July 2023 whether or not you wish to have your representation withdrawn.

If you wish to continue with your representation, I have arranged for a Licensing Sub Committee hearing to take place on 08 August 2023 at Dorset Council Offices, County Hall, Dorchester, DT1 1XJ, a formal invite will be sent out to you in due course

I would also like to inform you that any premises that holds a licence under the Licensing Act 2003, can be subject to a review at any time if an establishment fails to satisfy one or all of the four licensing objectives. (The prevention of crime and disorder, public safety, prevention of public nuisance and the protection of children from harm). A review would be heard at a Licensing Sub Committee where conditions or restrictions may be added to the licence to resolve outstanding issues.
