## HARBOURS, DOCKS, PIERS AND FERRIES

The Weymouth Harbour Revision Order 202[]

Dorset Council has applied for a harbour revision order in accordance with section 14(2)(a) of the Harbours Act 1964(a) ("the Act").

The Secretary of State, as the appropriate Minister for the purposes of that section, has by an Order(b) under section 42A of the Act(c) delegated the functions of the appropriate Minister under section 14(d) to the Marine Management Organisation(e).

The Marine Management Organisation, being satisfied as mentioned in section 14(2)(b), and in exercise of the powers conferred by section 14(1) and (3) of the Act, makes the following Order.

### PART 1

### PRELIMINARY

#### Citation, commencement and extent

**1.**—(1) This Order may be cited as the Weymouth Harbour Revision Order 202[] and shall come into force on [DATE].

(2) The Weymouth Harbour Acts and Orders 1854 to 2021 and this Order may be cited together as the Weymouth Harbour Acts and Orders 1854 to 202[].

(3) This Order extends to England and Wales.

#### Interpretation

**2.**—(1) In this Order—

"the Act of 1847" means the Harbours, Docks and Piers Clauses Act 1847(a);

"the Order of 2021" means the Weymouth Harbour Revision Order 2021(b);

"the Council" means Dorset Council;

"peninsula plan" means the plan prepared in duplicate, signed on behalf of the Marine Management Organisation and marked "Signed peninsula plan referred to in the Weymouth Harbour Revision Order 202[]", one copy of which is deposited at the offices of the Marine Management Organisation(c) and the other at the principal office of the Council(d);

"Trinity House" means the Corporation of Trinity House of Deptford Strond(e);

"the Weymouth Harbour Acts and Orders 1854 to 2021" means the Acts and Orders referred to in Schedule 3 to the Order of 2021 (Acts and Orders) and the Order of 2021.

#### Restriction of the application of section 33 of the Harbours, Docks and Piers Clauses Act 1847

**3.**—(1) Subject to paragraph (2), section 33 of the Act of 1847 (harbour, dock, and pier free to the public on payment of rate), as incorporated under article 3 of the Order of 2021 (incorporation of the provisions of Harbour, Docks and Piers Clauses Act 1847) shall only apply in respect of vessels up to 24 metres in length.

(2) Section 33 of the Act of 1847 shall not apply to the area shaded [insert] on the peninsula plan.

#### **Saving for Trinity House**

**4.** Nothing in this Order shall prejudice or derogate from any of the rights, duties or privileges of Trinity House.

### **Crown Rights**

5.—(1) Nothing in this Order shall—

- (a) prejudicially affect any estate, right, power, privilege, authority or exemption of the Crown;
- (b) authorise the Council or any licensee to take, use, enter upon or in any manner interfere with any land or interests in land or any rights of whatsoever description (including any portion of the shore or bed of the sea or of any river, channel, creek, bay or estuary) belonging to—
  - (i) His Majesty in right of His Crown and under the management of the Crown Estate Commissioners, without the consent in writing of the Crown Estate Commissioners,
  - (ii) a government department or held in trust for His Majesty for the purposes of a government department without the consent in writing of that government department.

(2) A consent under paragraph (1)(b) may be given unconditionally or subject to such conditions and upon such terms as may be considered necessary or appropriate.

# EXPLANATORY NOTE

(This note is not part of the Order)

This Order, made on the application of Dorset Council, amends the statutory harbour powers applying in relation to Weymouth harbour and provides for—

(1) The restriction of section 33 of the Harbours, Docks and Piers Clauses Act 1847 ('the Open Port Duty') in its application to Weymouth harbour (article 3).

(2) Savings for Trinity House (article 4) and Crown Rights (article 5).

An impact assessment has not been prepared for this Order as there is no, or no significant, impact predicted on businesses, charities, voluntary bodies or the public sector.
