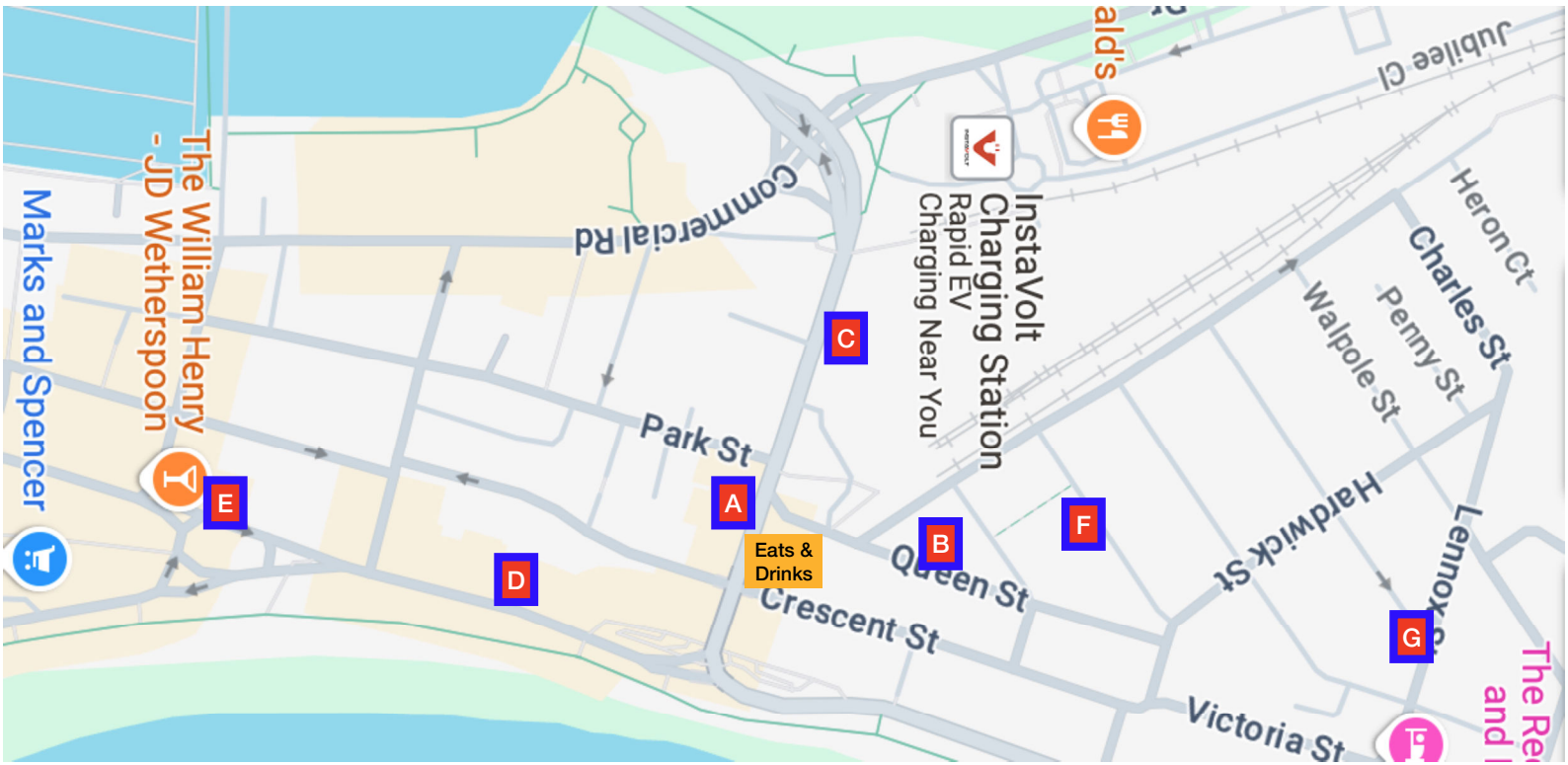

The figures from Simply Business last year showed more than half small business owners experienced mental health issues over the previous 12 months. Mental Health UK found four fifths of small business owners experience common symptoms of poor mental health at least a few times a year. Eight out of ten reported symptoms of poor mental health with more women than men affected and only 4 in 10 had looked for support. Business owners report inability to focus (66%), anxiety (64%) and disrupted sleep (63%). Almost a quarter have panic attacks and more than a third experience symptoms of depression.

Four in ten put this down to the impact of financial worries but there are a host of other contributing factors. Small business owners don't take time off when they're struggling. They have to keep the show on the road, hit deadlines, deliver goods and services and often there's no one to step in to help. They work longer hours than employees and take less time off for holidays. Add to that sleeplessness due to worry about all the above-mentioned factors and you have the perfect recipe for anxiety, depression, burn out and loneliness. Despite this, half don't feel comfortable disclosing poor mental health as a reason for time off or for delaying deadlines.

Its survey of 1,000 business owners finds that a third (34%) of all small business owners state that their mental health declined over the course of the pandemic. Latest **Government figures** show that there are 5.5 million small businesses across the UK, indicating that 1,800,000 have suffered a mental wellbeing hit due to Covid.

Across all respondents, one in four (24%) report that they currently have a mental health condition such as anxiety, depression or post-traumatic stress. Among disabled entrepreneurs, the figure rises to four in ten (43%). One in seven (15%) small business owners report having a mild mental health condition, with 6% and 2% respectively stating that they have a moderate or severe condition as **defined by NICE**.

The common causes

Inability to focus (66%) was most commonly reported by small business owners, followed by the anxiety (64%) and disrupted sleep (63%). Almost a quarter (24%) have panic attacks and 37% experience symptoms of depression.

SMALL BUSINESS OWNERS AT BREAKING POINT

Alongside acute financial worries, it's clear that long hours and a lack of rest are taking their toll on the country's SME owners. Almost one in six (15%) believe a lack of time off is directly impacting their mental health.

As one in three (33%) open up about experiencing burnout, the research reveals that small business owners are working over 46 hours a week on average – 10 hours more than the average working hours clocked up by workers in the UK (36.4 hours according to ONS data).

What's more, three quarters (73%) take fewer than 20 days off each year – well below the UK statutory annual leave entitlement of 28 days. Throw lack of sleep into the mix – 44% report struggling with
