To ensure Cabinet are fully informed of the current DCOE performance.



Appendix 1 Overview

As a local authority, Dorset Council has a duty under Section 42, Children and Families Act 2014 to secure special educational provision and health care provision in accordance with EHC Plans. The Council also has in place a plan for managing the High Needs Block funding, used to pay for special education provision, which forms part of the Safety Valve arrangements with the Department for Education.

The Dorset Centre of Excellence (DCOE) was established to enable Dorset Council to:

- deliver special education provision (at a reduced capital cost from, and quicker than, new build alternatives)
- deliver these at lower cost to independent providers and higher value for money (i.e. taking into account cost avoidance and other benefits)
- secure places for Dorset children & young people and a high degree of control over quality/nature of the provision (resulting in better outcomes for pupils and better value for money)

DCOE was established in 2021, and Coombe House School has been operational for 2 full academic years. There are over 112 pupils on role at the school and in this relatively short space of time DCOE have:

- Established and embedded strong leadership and governance, including financial management, with an unqualified Independent Auditors Report and the Ofsted inspection recognising 'GOOD' leadership and management
- Developed broad and aspirational curriculum, with innovative practice to enhance the offer to pupils; and addressed the areas for improvement identified in the 2023 Ofsted inspection
- Invested in teaching staff, the school environment and the therapeutic offer, to meet the needs of pupils
- Managed the growth in pupil number steadily and well, including the recruitment and retention of staff
- Worked as part of the local education community in Dorset, sharing practice and expertise

- Invested in community engagement, for the benefit of local people (such as community use of the swimming pool) and for the benefit of pupils (in terms of involvement and engagement with the local community as part of 'preparation for adulthood').
- Taken positive steps to reduce the carbon footprint
